# Transverse exponential stability and applications

## Abstract

We investigate how the following properties are related to each other: i) - A manifold is “transversally” exponentially stable; ii) - The “transverse” linearization along any solution in the manifold is exponentially stable; iii) - There exists a field of positive definite quadratic forms whose restrictions to the directions transversal to the manifold are decreasing along the flow. We illustrate their relevance with the study of exponential incremental stability. Finally, we apply these results to two control design problems, nonlinear observer design and synchronization. In particular, we provide necessary and sufficient conditions for the design of nonlinear observer and of nonlinear synchronizer with exponential convergence property.

## 1 Introduction

The property of attractiveness of a (non-trivial) invariant manifold is often sought in many control design problems. In the classical internal model based output regulation [16], it is known that the closed-loop system must have an attractive invariant manifold, on which, the tracking error is equal to zero. In the Immersion & Invariance [6], in the sliding-mode control approaches, or observer designs [3], obtaining an attractive manifold is an integral part of the design procedure. Many multi-agent system problems, such as, formation control, consensus and synchronization problems, are also closely related to the analysis and design of an attractive invariant manifold, see, for example, [8, 29, 34].

The study of stability and/or attractiveness of invariant manifolds and more generally of sets has a long history. See for instance [35, §16] and the references therein. In this paper, we focus on the exponential convergence property by studying the system linearized transversally to the manifold. We show that this attractiveness property is equivalent to the existence of positive definite quadratic forms which are decreasing along the flow of the transversally linear system. For constant quadratic forms and when the system has some specific structure, the latter becomes the Demidovich criterion which is a sufficient, but not yet necessary, condition for convergent systems [22, 23, 25]. On the other hand, if we consider the standard output regulation theory as pursued in [16], the attractiveness of the invariant manifold is established using the center manifold theorem which corresponds to the stability property of the linearized system at an equilibrium point. Due to the lack of characterization

of an attractive invariant manifold, most of the literature on constructive design for nonlinear output regulator is based on various different sufficient conditions that can be very conservative. In these regards, our main results can potentially provide a new framework for control designs aiming at making an invariant manifold attractive.

The paper is divided into two parts. In Subsection 2.1, we study a dynamical system that admits a transverse exponentially stable invariant manifold. In particular, we establish equivalent relations between:

- (i) the transverse exponential stability of an invariant manifold;
- (ii) the exponential stability of the transverse linearized system;
- (iii) the existence of field of positive definite quadratic forms the restrictions to the transverse direction to the manifold of which are decreasing along the flow.

We illustrate these results by considering a particular case of exponential incremental stable systems in Subsection 2.2. Here, incremental stability refers to the property where the distance between any two trajectories converges to zero (see, for example, [4, 12, 5]). For such systems, the property (i)  $\Leftrightarrow$  (iii) is used to prove that the exponential incremental stability property is equivalent to the existence of a Riemannian distance which is contracted by the flow.

In the second part of the paper, we apply the equivalence results to two different control problems: nonlinear observer design and synchronization of nonlinear multi-agent systems. In both problems, a necessary condition is obtained. Based on this necessary condition, we propose a novel design for an observer, in Subsection 3.1, and for a synchronizer, in Subsection 3.2.

In Subsection 3.1, we reinterpret the three properties (i), (ii) and (iii) in the context of observer design. This allows us to revisit some of the results obtained recently in [27] and [1] and, more importantly, to show that the sufficient condition given in [27] is actually also a necessary condition to design an exponential (local) full-order observer.

Finally, in Subsection 3.2, we solve a nonlinear synchronization problem. In particular, we give some necessary and sufficient conditions to achieve (local) exponential synchronization of nonlinear multi-agent systems involving more than two agents. This result generalizes our preliminary work in [2]. Moreover, under an extra assumption, we show how to obtain a global synchronization for the two agents case.

It is worth noting that our main results are applicable to other control problems beyond the two control problems mentioned before. In a recent paper by Wang, Ortega & Su [33], our results have been applied to solve an adaptive control problem via the Immersion & Invariance principle.

## 2 Main result

### 2.1 Transversally exponentially stable manifold

Throughout this section, we consider a system in the form

$$\dot{e} = F(e, x) , \quad \dot{x} = G(e, x) \tag{1}$$

where  $e$  is in  $\mathbb{R}^{n_e}$ ,  $x$  is in  $\mathbb{R}^{n_x}$  and the functions  $F : \mathbb{R}^{n_e} \times \mathbb{R}^{n_x} \rightarrow \mathbb{R}^{n_e}$  and  $G : \mathbb{R}^{n_e} \times \mathbb{R}^{n_x} \rightarrow \mathbb{R}^{n_x}$  are  $C^2$ . We denote by  $(E(e_0, x_0, t), X(e_0, x_0, t))$  the (unique) solution which goes through  $(e_0, x_0)$  in  $\mathbb{R}^{n_e} \times \mathbb{R}^{n_x}$  at time  $t = 0$ . We assume it is defined for all positive times, i.e. the system is *forward complete*.

The system (1) above can be used, for example, to study the behavior of two distinct solutions  $X(x_1, t)$  and  $X(x_2, t)$  of the system defined on  $\mathbb{R}^n$  by

$$\dot{x} = f(x) \tag{2}$$

Indeed, we obtain an  $(e, x)$ -system of the type (1) with

$$F(e, x) = f(x + e) - f(x) , \quad G(e, x) = f(x) . \quad (3)$$

This is the context of incremental stability that we will use throughout this section to illustrate our main results.

In the following, to simplify our notations, we denote by  $B_e(a)$  the open ball of radius  $a$  centered at the origin in  $\mathbb{R}^{n_e}$ .

We study the links between the following three notions.

**TULES-NL** (*Transversal uniform local exponential stability*)

The system (1) is forward complete and there exist strictly positive real numbers  $r$ ,  $k$  and  $\lambda$  such that we have, for all  $(e_0, x_0, t)$  in  $B_e(r) \times \mathbb{R}^{n_x} \times \mathbb{R}_{\geq 0}$ ,

$$|E(e_0, x_0, t)| \leq k|e_0| \exp(-\lambda t) . \quad (4)$$

**UES-TL** (*Uniform exponential stability for the transversally linear system*)

The system

$$\dot{\tilde{x}} = \tilde{G}(\tilde{x}) := G(0, \tilde{x}) \quad (5)$$

is forward complete and there exist strictly positive real numbers  $\tilde{k}$  and  $\tilde{\lambda}$  such that any solution  $(\tilde{E}(\tilde{e}_0, \tilde{x}_0, t), \tilde{X}(\tilde{x}_0, t))$  of the transversally linear system

$$\dot{\tilde{e}} = \frac{\partial F}{\partial e}(0, \tilde{x})\tilde{e} , \quad \dot{\tilde{x}} = \tilde{G}(\tilde{x}) \quad (6)$$

satisfies, for all  $(\tilde{e}_0, \tilde{x}_0, t)$  in  $\mathbb{R}^{n_e} \times \mathbb{R}^{n_x} \times \mathbb{R}_{\geq 0}$ ,

$$|\tilde{E}(\tilde{e}_0, \tilde{x}, t)| \leq \tilde{k} \exp(-\tilde{\lambda} t) |\tilde{e}_0| . \quad (7)$$

**ULMTE** (*Uniform Lyapunov matrix transversal equation*)

For all positive definite matrix  $Q$ , there exists a continuous function  $P : \mathbb{R}^{n_x} \rightarrow \mathbb{R}^{n_e \times n_e}$  and strictly positive real numbers  $\underline{p}$  and  $\bar{p}$  such that  $P$  has a derivative  $\mathfrak{d}_{\tilde{G}}P$  along  $\tilde{G}$  in the following sense

$$\mathfrak{d}_{\tilde{G}}P(\tilde{x}) := \lim_{h \rightarrow 0} \frac{P(\tilde{X}(\tilde{x}, h)) - P(\tilde{x})}{h} \quad (8)$$

and we have, for all  $\tilde{x}$  in  $\mathbb{R}^{n_x}$ ,

$$\mathfrak{d}_{\tilde{G}}P(\tilde{x}) + P(\tilde{x}) \frac{\partial F}{\partial e}(0, \tilde{x}) + \frac{\partial F}{\partial e}(0, \tilde{x})' P(\tilde{x}) \leq -Q \quad (9)$$

$$\underline{p}I \leq P(\tilde{x}) \leq \bar{p}I . \quad (10)$$

In other words, the system (1) is said to be TULES-NL if the manifold  $\mathcal{E} := \{(e, x) : e = 0\}$  is exponentially stable for the system (1), locally in  $e$  and uniformly in  $x$ ; and it is said to be UES-TL if the manifold  $\tilde{\mathcal{E}} := \{(\tilde{x}, \tilde{e}) : \tilde{e} = 0\}$  of the linearized system transversal to  $\mathcal{E}$  in (6) is exponentially stable uniformly in  $\tilde{x}$ .

Concerning the ULMTE property, condition (9) is related to the notion of horizontal contraction introduced in [11, Section VII]). However a key difference is that we do not require the monotonicity condition (9) to hold in the whole manifold  $\mathbb{R}^{n_e} \times \mathbb{R}^{n_x}$  but only along the invariant submanifold  $\mathcal{E}$ . In this case the corresponding horizontal Finsler-Lyapunov function  $V : (\mathbb{R}^{n_x} \times \mathbb{R}^{n_e}) \times (\mathbb{R}^{n_x} \times \mathbb{R}^{n_e})$  that we get takes the form  $V((x, e), (\delta_x, \delta_e)) = \delta_e' P(x) \delta_e$ .

In the case where the manifold is reduced to a single point, i.e. when the system (1) is simply  $\dot{e} = F(e)$  with an equilibrium point at the origin (i.e.  $F(0) = 0$ ) then

- the TULES-NL property can be understood as the local exponential stability of the origin;
- the UES-TL notion translates to the exponential stability of the linear system  $\dot{\tilde{e}} = \frac{\partial F}{\partial e}(0)\tilde{e}$ ; and
- the ULMTE concept is about the existence of a positive definite matrix  $P$  solution to the Lyapunov equation  $P\frac{\partial F}{\partial e}(0) + \frac{\partial F}{\partial e}(0)^\top P = -Q$  where  $Q$  is an arbitrary positive definite matrix.

In this particular case it is well known that these three properties are equivalent.

For the example of incremental stability, as mentioned before, the three properties of TULES-NL, UES-TL and ULMTE can be understood globally as follows :

P1 (TULES-NL) *System (2) is globally exponentially incrementally stable. Namely there exist two strictly positive real numbers  $k$  and  $\lambda$  such that for all  $(x_1, x_2)$  in  $\mathbb{R}^n \times \mathbb{R}^n$  we have, for all  $t$  in  $\mathbb{R}_{\geq 0}$ ,*

$$|X(x_1, t) - X(x_2, t)| \leq k|x_1 - x_2| \exp(-\lambda t). \quad (11)$$

P2 (UES-TL) *The manifold  $\mathcal{E} = \{(x, e), e = 0\}$  is globally exponentially stable for the system*

$$\dot{e} = \frac{\partial f}{\partial x}(x)e, \quad \dot{x} = f(x) \quad (12)$$

*Namely there exist two strictly positive real numbers  $k_e$  and  $\lambda_e$  such that for all  $(e, x)$  in  $\mathbb{R}^n \times \mathbb{R}^n$ , the corresponding solution of (12) satisfies*

$$|E(e, x, t)| \leq k_e|e| \exp(-\lambda_e t), \quad \forall t \in \mathbb{R}_{\geq 0}.$$

P3 (ULMTE) *There exists a positive definite matrix  $Q$  in  $\mathbb{R}^{n \times n}$ , a  $C^2$  function  $P : \mathbb{R}^n \rightarrow \mathbb{R}^{n \times n}$  and strictly positive real numbers  $\underline{p}$  and  $\bar{p}$  such that  $P$  has a derivative  $\mathfrak{d}_f P$  along  $f$  in the sense of (22), and satisfies (21) and (19).*

In this context it is known that  $P3 \Rightarrow P1$ . Actually asymptotic incremental stability for which Property P1 is a particular case is known to be equivalent to the existence of an appropriate Lyapunov function. This has been established in [36, 32, 4] or [25] for instance. In our context, this Lyapunov function is given as a Riemannian distance. We shall show below that, as for the case of an equilibrium point, we have also  $P1 \Rightarrow P2 \Rightarrow P3$ , (see Proposition 4), namely incremental exponential stability implies the existence of a Riemannian distance for which the flow is contracting.

In studying the equivalence relation between TULES-NL, UES-TL and ULMTE, we are not interested in the possibility of a solution near the invariant manifold to inherit some properties of solutions in this manifold, such as, the asymptotic phase, the shadowing property, the reduction principle, etc., nor in the existence of some special coordinates allowing us to exhibit some invariant splitting in the dynamics (exponential dichotomy). This is the reason that, besides forward completeness, we assume nothing for the in-manifold dynamics given by :

$$\dot{\tilde{x}} = \tilde{G}(\tilde{x}) = G(0, \tilde{x}).$$

So, for not misleading our reader, we prefer to use the word “transversal” instead of “normal” as seen for instance in the various definitions of normally hyperbolic submanifolds given in [14, §1].

In order to simplify the exposition of our results and to concentrate our attention on the main ideas, we assume everything is global and/or uniform, including restrictive bounds. Most of this can be relaxed with working on open or compact sets, but then with restricting the results to time intervals where a solution remains in such a particular set.

### 2.1.1 TULES-NL “ $\Rightarrow$ ” UES-TL

In the spirit of Lyapunov first method, we have the following result.

**Proposition 1.** *If Property TULES-NL holds and there exist positive real numbers  $\rho$ ,  $\mu$  and  $c$  such that, for all  $x$  in  $\mathbb{R}^{n_x}$ ,*

$$\left| \frac{\partial F}{\partial e}(0, x) \right| \leq \mu, \quad \left| \frac{\partial G}{\partial x}(0, x) \right| \leq \rho \quad (13)$$

and, for all  $(e, x)$  in  $B_e(kr) \times \mathbb{R}^{n_x}$ ,

$$\left| \frac{\partial^2 F}{\partial e \partial e}(e, x) \right| \leq c, \quad \left| \frac{\partial^2 F}{\partial x \partial e}(e, x) \right| \leq c, \quad \left| \frac{\partial G}{\partial e}(e, x) \right| \leq c, \quad (14)$$

then Property UES-TL holds.

The proof of this proposition is given in Appendix .1. Roughly speaking, it is based on the comparison between a given  $e$ -component of a solution  $\tilde{E}(\tilde{e}_0, \tilde{x}_0, t)$  of (6) with pieces of  $e$ -component of solutions  $E(\tilde{e}_i, \tilde{x}_i, t - t_i)$  of solutions of (1) where  $\tilde{e}_i, \tilde{x}_i$  are sequences of points defined on  $\tilde{E}(\tilde{e}_0, \tilde{x}_0, t)$ . Thanks to the bounds (13) and (14), it is possible to show that  $\tilde{E}$  and  $E$  remain sufficiently closed so that  $\tilde{E}$  inherit the convergence property of the solution  $E$ . As a consequence, in the particular case in which  $F$  does not depend on  $x$ , the two functions  $E$  and  $\tilde{E}$  do not depend on  $x$  either and the bounds on the derivatives of the  $G$  function are useless.

### 2.1.2 UES-TL “ $\Rightarrow$ ” ULMTE

Analogous to the property of existence of a solution to the Lyapunov matrix equation, we have the following proposition on the link between UES-TL and ULMTE notions.

**Proposition 2.** *If Property UES-TL holds and there exists a positive real number  $\mu$  such that*

$$\left| \frac{\partial F}{\partial e}(0, x) \right| \leq \mu \quad \forall x \in \mathbb{R}^{n_x}, \quad (15)$$

then Property ULMTE holds.

The proof of this proposition is given in Appendix .2. The idea is to show that, for every symmetric positive definite matrix  $Q$ , the function  $P : \mathbb{R}^{n_x} \rightarrow \mathbb{R}^{n_e \times n_e}$  given by

$$P(\tilde{x}) = \lim_{T \rightarrow +\infty} \int_0^T \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s) \right)' Q \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s) ds \quad (16)$$

is well defined, continuous and satisfies all the requirements of the property ULMTE. The assumption (15) is used to show that  $P$  satisfies the left inequality in (10). Nevertheless this inequality holds without (15) provided the function  $s \mapsto \left| \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s) \right|$  does not go too fast to zero.

### 2.1.3 ULMTE “ $\Rightarrow$ ” TULES-NL

**Proposition 3.** *If Property ULMTE holds and there exist positive real numbers  $\eta$  and  $c$  such that, for all  $(e, x)$  in  $B_e(\eta) \times \mathbb{R}^{n_x}$ ,*

$$\left| \frac{\partial P}{\partial x}(x) \right| \leq c, \quad (17)$$

$$\left| \frac{\partial^2 F}{\partial e \partial e}(e, x) \right| \leq c, \quad \left| \frac{\partial^2 F}{\partial x \partial e}(e, x) \right| \leq c, \quad \left| \frac{\partial G}{\partial e}(e, x) \right| \leq c, \quad (18)$$

then Property TULES-NL holds.

The proof of this proposition can be found in Appendix .3. This is a direct consequence of the use of  $V(e, x) = e'P(x)e$  as a Lyapunov function. The bounds (17) and (18) are used to show that, with equation (9), the time derivative of this Lyapunov function is negative in a (uniform) tubular neighborhood of the manifold  $\{(e, x), e = 0\}$ .

## 2.2 Revisiting the exponential incremental stable systems

Incremental stability of an autonomous system (2) is the property that a distance between any two solutions of (2) converges asymptotically to zero. The characterization of it has been studied thoroughly, for example, in [4, 12, 5]. In [4, 5], a Lyapunov characterization of incremental stability ( $\delta$ -GAS for autonomous systems and  $\delta$ -ISS for non-autonomous ones) is given based on the Euclidean distance between two states that evolve in an identical system. A variant of this notion is that of convergent systems discussed in [22, 25]. All these studies are based on the notion of contracting flows which has been widely studied in the literature and for a long time, see, for example, [18, 19, 13, 9, 21, 20, 11]. These flows generate trajectories between which an appropriately defined distance is monotonically decreasing with increasing time. See [17] for a historical discussion on the contraction analysis and [30] for a partial survey.

The big issue in this view points is to find the appropriate distance which may be a difficult task. The results in Section 2 may help in this regard with providing an explicit construction of a Riemannian distance.

Precisely, let  $P$  be a  $C^2$  function defined on  $\mathbb{R}^n$  the values of which are symmetric matrices satisfying

$$\underline{p}I \leq P(x) \leq \bar{p}I \quad \forall x \in \mathbb{R}^n \quad (19)$$

The length of any piece-wise  $C^1$  path  $\gamma : [s_1, s_2] \rightarrow \mathbb{R}^n$  between two arbitrary points  $x_1 = \gamma(s_1)$  and  $x_2 = \gamma(s_2)$  in  $\mathbb{R}^n$  is defined as :

$$L(\gamma) \Big|_{s_1}^{s_2} = \int_{s_1}^{s_2} \sqrt{\frac{d\gamma}{ds}(\sigma)' P(\gamma(\sigma)) \frac{d\gamma}{ds}(\sigma)} d\sigma \quad (20)$$

By minimizing along all such path we get the distance  $d(x_1, x_2)$ .

Then, thanks to the well established relation between (geodesically) monotone vector field (semi-group generator) (operator) and contracting (non-expansive) flow (semi-group) (see [18, 13, 7, 15] and many others), we know that this distance between any two solutions of (2) is exponentially decreasing to 0 as time goes on forward if we have

$$\mathfrak{D}_f P(x) + P(x) \frac{\partial f}{\partial x}(x) + \frac{\partial f}{\partial x}(x)' P(x) \leq -Q \quad \forall x \in \mathbb{R}^n, \quad (21)$$

where  $Q$  is a positive definite symmetric matrix and

$$\mathfrak{D}_f P(x) = \lim_{h \rightarrow 0} \frac{P(X(x, h)) - P(x)}{h}. \quad (22)$$

For a proof, see for example [18, Theorem 1] or [15, Theorems 5.7 and 5.33] or [24, Lemma 3.3] (replacing  $f(x)$  by  $x + hf(x)$ ).

In this context, using the main results of our previous section, we can show that, if we have exponential incremental stability, then there exists a function  $P$  meeting the above requirements. Specifically, we have the following proposition.

**Proposition 4** (Incremental stability). *Assume the system (2) is forward complete with a function  $f$  which is  $C^3$  with bounded first, second and third derivatives. Let  $X(x, t)$  denotes its solutions. Then we have  $P1 \Rightarrow P2 \Rightarrow P3$  (and therefore  $P1 \Leftrightarrow P2 \Leftrightarrow P3$ ).*

In other words, exponential incremental stability property is equivalent to the existence of a Riemannian distance which is contracted by the flow and can be used as a  $\delta$ -GAS Lyapunov function. Note also that, despite the fact that the main results in Section 2 are local, when we restrict ourselves to the incremental stability problem, we can obtain a global result.

*Proof:  $P1 \Rightarrow P2 \Rightarrow P3$ :* Consider the system (3) and let  $n_x = n_e = n$ . The boundedness of the first derivative of  $f$  implies the forward completeness of the corresponding systems (1) and (5). Moreover the inequalities (13), (14) and (15) with  $r = +\infty$  follow from the assumption of boundedness of the derivatives of  $f$ .

As a consequence  $P1 \Rightarrow P2$  follows from Proposition 1 and  $P2 \Rightarrow P3$  from Proposition 2. Note however that it remains to show that  $P$  defined in (16) is  $C^2$ . This is obtained employing the boundedness of the first, second and third derivatives of  $f$ . Indeed, note that we have for all  $(t, x)$   $\frac{\partial \tilde{E}}{\partial e}(0, x, t) = \frac{\partial X}{\partial x}(x, t)$ . So to show that  $P$  is  $C^1$  it suffices to show that the mapping  $t \mapsto \frac{\partial^2 X}{\partial x_i \partial x}(x, t)$  goes exponentially to zero as time goes to infinity. Note that this is indeed the case since given a vector  $v$  in  $\mathbb{R}^n$  and  $i$  in  $\{1, \dots, n\}$  the mapping  $\nu(t) = \frac{\partial^2 X}{\partial x_i \partial x}(x, t)v$  is solution to

$$\dot{\nu} = \frac{\partial f}{\partial x}(X(x, t))\nu + \sum_{j=1}^n \frac{\partial^2 f}{\partial x_j \partial x}(X(x, t)) \frac{\partial X_j}{\partial x_i}(x, t) \frac{\partial X}{\partial x}(x, t)v$$

Hence, from (21), (19) and the fact that  $f$  has bounded second derivatives, it yields the existence of a positive real number  $\tilde{c}$  such that

$$\overline{\nu' P(X(x, t)) \nu} \leq -\nu' Q \nu + \tilde{c} |\nu| \left| \frac{\partial X}{\partial x}(x, t) \right|^2.$$

Since  $t \mapsto \frac{\partial X}{\partial x}(x, t)$  exponentially goes to zero as time goes to infinity, it implies that  $\nu$  exponentially goes to zero. Hence,  $P$  is  $C^1$ . Employing the bound on the third derivative and following the same route, it follows that  $P$  is  $C^2$ .  $\square$



### 3 Applications

In this section, we apply Propositions 1, 2 and 3 in two different contexts: full order observer and synchronization.

#### 3.1 Nonlinear observer design

Consider a system

$$\dot{x} = f(x), \quad y = h(x). \quad (23)$$

with state  $x$  in  $\mathbb{R}^n$  and output  $y$  in  $\mathbb{R}^p$  augmented with a state observer of the particular form

$$\dot{\hat{x}} = f(\hat{x}) + K(y, \hat{x}) \quad (24)$$

with state  $\hat{x}$  in  $\mathbb{R}^n$  and where

$$K(h(x), x) = 0 \quad \forall x. \quad (25)$$

Assuming the functions  $f$ ,  $h$  and  $K$  are  $C^2$ , we are interested in having the manifold  $\{(x, \hat{x}) : x = \hat{x}\}$  exponentially stable for the overall system

$$\dot{x} = f(x), \quad \dot{\hat{x}} = f(\hat{x}) + K(y, \hat{x}). \quad (26)$$

When specified to this context, the properties TULES-NL, UES-TL and ULMTE are

**Exponentially convergent observer (TULES-NL):** The system (26) is forward complete and there exist strictly positive real numbers  $r$ ,  $k$  and  $\lambda$  such that we have, for all  $(x, \hat{x}, t)$  in  $\mathbb{R}^n \times \mathbb{R}^n \times \mathbb{R}_{\geq 0}$  satisfying  $|x_0 - \hat{x}_0| \leq r$ , we have

$$|X(x_0, t) - \hat{X}(x_0, \hat{x}_0, t)| \leq k|x_0 - \hat{x}_0| \exp(-\lambda t). \quad (27)$$

**UES-TL FOR OBSERVER** The system

$$\dot{x} = f(x)$$

is forward complete and there exist strictly positive real numbers  $\tilde{k}$  and  $\tilde{\lambda}$  such that any solution  $(\tilde{E}(\tilde{e}_0, x_0, t), X(x_0, t))$  of the transversally linear system

$$\dot{\tilde{e}} = \left[ \frac{\partial f}{\partial x}(x) + \frac{\partial K}{\partial y}(h(x), x) \frac{\partial h}{\partial x}(x) \right] \tilde{e}, \quad \dot{x} = f(x) \quad (28)$$

satisfies, for all  $(\tilde{e}_0, x_0, t)$  in  $\mathbb{R}^n \times \mathbb{R}^n \times \mathbb{R}_{\geq 0}$ ,

$$|\tilde{E}(\tilde{e}_0, x_0, t)| \leq \tilde{k} \exp(-\tilde{\lambda} t) |\tilde{e}_0|. \quad (29)$$

**ULMTE FOR OBSERVER :** For all positive definite matrix  $Q$ , there exists a continuous function  $P : \mathbb{R}^n \rightarrow \mathbb{R}^{n \times n}$  and strictly positive real numbers  $\underline{p}$  and  $\bar{p}$  such that we have, for all  $x$  in  $\mathbb{R}^n$ ,

$$\underline{p} I \leq P(x) \leq \bar{p} I,$$

$\mathfrak{d}_f P(x)$

$$+ 2\text{Sym} \left( P(x) \left[ \frac{\partial f}{\partial x}(x) + \frac{\partial K}{\partial y}(h(x), x) \frac{\partial h}{\partial x}(x) \right] \right) \quad (30)$$

$$\leq -Q.$$

where  $\text{Sym}(A) = A + A'$ .

Propositions 1, 2 and 3 give conditions under which these properties are equivalent. But these properties assume the data of the correction term  $K$ . Hence, by rewriting UES-TEL and TULES-NL in a way in which the design parameter  $K$  disappears, these propositions give necessary conditions for the existence of an exponentially convergent observer.

Property UES-TL involves the existence of an observer with correction term depending on  $x$  for the time-varying linear system resulting from the linearization along a solution to the system (23), i.e.

$$\dot{\tilde{e}} = \frac{\partial f}{\partial x}(x)\tilde{e}, \quad \tilde{y} = \frac{\partial h}{\partial x}(x)\tilde{e} \quad (31)$$

seeing  $\tilde{y}$  as output. As a consequence of Proposition 1, a necessary condition for Property UES-TL to hold and further, when some derivatives are bounded, for the existence of an exponentially convergent observer is that the system (23) be infinitesimally detectable in the following sense

**Infinitesimal detectability** We say that the system (23) is infinitesimally detectable if every solution of

$$\dot{x} = f(x), \quad \dot{\tilde{e}} = \frac{\partial f}{\partial x}(x)\tilde{e}, \quad \frac{\partial h}{\partial x}(x)\tilde{e} = 0$$

defined on  $[0, +\infty)$  satisfies  $\lim_{t \rightarrow +\infty} |\tilde{E}(e, x, t)| = 0$ .

A similar necessary condition has been established in [1] for a larger class of observers but under an extra assumption (the existence of a locally quadratic Lyapunov function).

**Example 1:** Consider the planar system

$$\dot{x}_1 = x_2^3, \quad \dot{x}_2 = -x_1, \quad y = x_1. \quad (32)$$

We wish to know whether or not it is possible to design an exponentially convergent observer for this nonlinear oscillator in the form of (24). The linearized system is

$$\dot{\tilde{e}}_1 = 3x_2^2\tilde{e}_2, \quad \dot{\tilde{e}}_2 = -\tilde{e}_1, \quad \tilde{y} = \tilde{e}_1 \quad (33)$$

This system is not detectable when the solution, along which we linearize, is the origin which is an equilibrium of (32). Consequently the system (32) is not infinitesimally detectable on  $\mathbb{R}^2$  and so there is no exponentially convergent observer on  $\mathbb{R}^2$ . Fortunately the subset  $\{x \in \mathbb{R}^2 : \frac{x_1^2}{2} + \frac{x_2^4}{4} \geq \epsilon\}$ , with  $\epsilon > 0$ , is invariant and (32) is infinitesimally detectable in it.

To design a correction term  $K$  for an exponentially convergent observer, we use the property that

$$L(y, x) = \frac{\partial K}{\partial y}(y, x)$$

should be an observer gain for the linear system (33). So we start our design by selecting  $L$ . We pick

$$L(y, x) = \begin{bmatrix} -3x_2^2 \\ -3x_2^2 + 1 \end{bmatrix}$$

This gives (see (28))

$$A(x) = \frac{\partial f}{\partial x}(x) + \frac{\partial K}{\partial y}(h(x), x) \frac{\partial h}{\partial x}(x) = 3x_2 \begin{bmatrix} -1 & 1 \\ 0 & -1 \end{bmatrix}$$

The transition matrix generated by  $A(X(x, t))$  when  $X(x, t)$  is a solution of (32) is

$$\Phi(t, 0) = \exp(-I(t)) \begin{bmatrix} 1 & I(t) \\ 0 & 1 \end{bmatrix}$$

where

$$I(t) = 3 \int_0^t X_2(x, s)^2 ds .$$

Since  $X_2(x, t)$  is periodic, (29) holds when the initial condition  $x$  is in the compact invariant subset

$$\mathcal{C} = \{x \in \mathbb{R}^2 : \frac{1}{\epsilon} \geq \frac{x_1^2}{2} + \frac{x_2^4}{4} \geq \epsilon\} . \quad (34)$$

Then, according to Propositions 2 and 3, and in view of (25), we obtain an exponentially convergent observer by choosing  $K$  as

$$K(y, x) = \int_{x_1}^y L(s, x) ds = \begin{bmatrix} -3x_2^2 \\ -3x_2^2 + 1 \end{bmatrix} (y - x_1) .$$

Similarly, Property ULMTE involves the existence of  $P$  and  $K$  such that (30) holds. By restricting this inequality on quadratic forms to vectors which are in the kernel of  $\frac{\partial h}{\partial x}$ , we obtain as a consequence of Propositions 1 and 2 that a necessary condition for Property ULMTE to hold and further, when some derivatives are bounded, for the existence of an exponentially convergent observer is that the system (23) be R-detectable (R for Riemann) in the following sense.

**R-Detectability** We say that the system (23) is R-detectable if there exist a continuous function  $P : \mathbb{R}^n \rightarrow \mathbb{R}^{n \times n}$  and positive real numbers  $0 < \underline{p} \leq \bar{p}$  and  $0 < \underline{q}$  such that  $P$  has a derivative  $\partial_f P$  along  $f$  in the sense of (22) and we have

$$\underline{p} I \leq P(x) \leq \bar{p} I \quad \forall x \in \mathbb{R}^n \quad (35)$$

and

$$v' \partial_f P(\tilde{x}) v + 2v' P(\tilde{x}) \frac{\partial f}{\partial x}(x) v \leq -\underline{q} v' P(x) v \quad (36)$$

holds for all  $(x, v)$  in  $\mathbb{R}^n \times \mathbb{R}^n$  satisfying  $\frac{\partial h}{\partial x}(x) v = 0$ .

A similar necessary condition has been established in [27], where only asymptotic and not exponential convergence is assumed. In that case, the condition allows  $\underline{p}$  and  $\underline{q}$  to be zero.

Further it is established in [28] that when the R-detectability holds then

$$K(y, x) = k P(x)^{-1} \frac{\partial h}{\partial x}(x)^T (y - h(x))$$

gives, for  $k$  large enough, a (locally) exponentially convergent observer.

**Example 1 continued:** For the system (32), the necessary R-Detectability condition is the existence of  $P = \begin{pmatrix} P_{11} & P_{12} \\ P_{12} & P_{22} \end{pmatrix}$  satisfying in particular (36) which is (see (34))

$$\frac{\partial P_{22}}{\partial x_1}(x) x_2^3 - \frac{\partial P_{22}}{\partial x_2}(x) x_1 + 6P_{12}(x) x_2^2 < -\underline{q} P_{22}(x) \quad \forall x \in \mathcal{C} \quad (37)$$

We view this as a condition on  $P_{22}$  only since whatever  $P_{12}$  is, we can always pick  $P_{11}$  to satisfy (35). Note also that we can take care of any term with  $x_2^2$  in factor by selecting  $P_{12}$  appropriately. With this, it can be shown that it is sufficient to pick  $P_{22}$  in the form

$$\left( \frac{r(x)}{2} \leq \right) \quad P_{22}(x) = r(x) + \frac{x_1 x_2}{\sqrt{r(x)}} + x_2^2 \quad (\leq 3r(x)) ,$$

where the presence of  $r$  defined below is justified by homogeneity considerations

$$(4\varepsilon \leq) \quad r(x) = \sqrt{2x_1^2 + x_2^4} \quad \left( \leq \frac{4}{\varepsilon} \right).$$

This motivates us to design

$$P_{12}(x) = -\frac{5}{24} \frac{x_2^2}{\sqrt{r(x)}} - \frac{1}{3} \sqrt{r(x)}$$

In this case, the left hand side in the inequality (37) is

$$\begin{aligned} -\frac{x_1^2}{\sqrt{r}} - \frac{1}{4} \frac{x_2^4}{\sqrt{r(x)}} + 2x_1x_2 - 2\sqrt{r(x)}x_2^2 \\ \leq -\frac{1}{4}r(x)\sqrt{r(x)} \leq -\frac{\sqrt{r(x)}}{12}P_{22}(x) \leq -\frac{\sqrt{\varepsilon}}{6}P_{22}(x). \end{aligned}$$

Finally, by choosing

$$P_{11}(x) = 2 + \frac{P_{12}(x)^2}{P_{22}(x) - \frac{r(x)}{4}},$$

it can be shown that we obtain

$$\varepsilon I \leq \min \left\{ 1, \frac{r(x)}{4} \right\} I \leq P(x) \leq 3 \max \{ 1, r(x) \} I \leq \frac{12}{\varepsilon}.$$

Hence (35) holds on  $\mathcal{C}$ . From this, the correction term

$$K(y, x) = \frac{kP_{22}(x)}{P_{11}P_{22}(x) - P_{12}(x)^2} \begin{pmatrix} P_{22}(x) \\ -P_{12}(x) \end{pmatrix} (y - x_1)$$

gives a (locally) convergent observer on  $\mathcal{C}$ .

### 3.2 Exponential synchronization

Finally, we revisit the synchronization problem as another class of control problems that can be dealt with the results in Section II. We consider here the synchronization of  $m \geq 2$  identical systems given by

$$\dot{w}_i = f(w_i) + g(w_i)u_i, \quad i = 1, \dots, m, \quad (38)$$

In this setting, all systems have the same drift vector field  $f$  and the same control vector field  $g : \mathbb{R}^n \rightarrow \mathbb{R}^{n \times p}$ , but not the same controls in  $\mathbb{R}^p$ . The state of the whole system is denoted  $w = (w_1, \dots, w_m)$  in  $\mathbb{R}^{mn}$ . We define also the diagonal subset of  $\mathbb{R}^{mn}$

$$\mathcal{D} = \{(w_1, \dots, w_m) \in \mathbb{R}^{mn}, w_1 = w_2 = \dots = w_m\}$$

Given  $w$  in  $\mathbb{R}^{mn}$ , we denote the Euclidean distance to the set  $\mathcal{D}$  as  $|w|_{\mathcal{D}}$ . The synchronization problem that we consider in this section is as follows.

**Definition 1.** *The control laws  $u_i = \phi_i(w)$ ,  $w = (w_1, \dots, w_m)$ ,  $i = 1, \dots, m$  solve the local uniform exponential synchronization problem for (38) if the following holds:*

1.  $\phi$  is invariant by permutation of agents. More precisely, given a permutation  $\pi : \{1, \dots, m\} \mapsto \{1, \dots, m\}$

$$\phi_{\pi_i}(w_1, \dots, w_m) = \phi_i(w_{\pi_1}, \dots, w_{\pi_m})$$

2.  $\phi$  is zero on  $\mathcal{D}$ :

$$\phi(w) = 0 \quad \forall w \in \mathcal{D}, \quad (39)$$

3. and the set  $\mathcal{D}$  is uniformly exponentially stable for the closed-loop system, i.e., there exist positive real numbers  $r_w$ ,  $k$  and  $\lambda > 0$  such that, for all  $w$  in  $\mathbb{R}^{mn}$  satisfying  $|w|_{\mathcal{D}} < r_w$ ,

$$|W(w, t)|_{\mathcal{D}} \leq k \exp(-\lambda t) |w|_{\mathcal{D}}, \quad (40)$$

holds for all  $t$  in the domain of existence of the solutions  $W(w, t)$  going through  $w$  at  $t = 0$ .

When  $r_w = \infty$ , it is called the global uniform exponential synchronization problem.

In this context, we assume that every agent shares an information (which will be designed later) to all other agents (in which case, it forms a complete graph) and it has local access to its state variables.

It is possible to rewrite the property of having the manifold  $\mathcal{D}$  exponentially stable as property TULES-NL. As it has been done in the observer design context, employing Propositions 1 and 2 and by rewriting properties UES-TL and ULMTE it is possible to give equivalent characterization of the synchronization property. By rewriting these conditions in a way in which the control law disappears, these properties give necessary conditions to achieve exponential synchronization.

**Proposition 5** (Necessary condition). *Consider the systems in (38) and assume the existence of control laws  $u_i = \phi_i(w)$ ,  $i = 1, \dots, m$  that solve the uniform exponential synchronization of (38). Assume moreover that  $g$  is bounded and  $f$ ,  $g$  and the  $\phi_i$ 's have bounded first and second derivatives. Then the following two properties hold.*

Q1: *The origin of the transversally linear system*

$$\dot{\tilde{e}} = \frac{\partial f}{\partial x}(\tilde{x})\tilde{e} + g(\tilde{x})u, \quad \dot{\tilde{x}} = f(\tilde{x}), \quad (41)$$

is stabilizable by a (linear in  $\tilde{e}$ ) state feedback.

Q2: *For every positive definite matrix  $Q$ , there exist a continuous function  $P : \mathbb{R}^n \rightarrow \mathbb{R}^{n \times n}$  and positive real numbers  $\underline{p}$  and  $\bar{p}$  such that inequalities (19) are satisfied,  $P$  has a derivative  $\mathfrak{d}_f P$  along  $f$  in the sense of (22), and*

$$\mathfrak{d}_f v' P(x)v + 2v' P(x) \frac{\partial f}{\partial x}(x)v \leq -v' Qv \quad (42)$$

holds for all  $(v, x)$  in  $\mathbb{R}^{2n}$  satisfying  $v' P(x)g(x) = 0$ .

*Proof* : First of all note that the vector fields having bounded first derivatives, it implies that the system is complete. Consider  $(i, j, k, l)$ , 4 integers in  $\{1, \dots, m\}$  and consider a permutation  $\pi : \{1, \dots, m\} \mapsto \{1, \dots, m\}$  such that  $\pi_i = k$  and  $\pi_j = l$ . Note that  $k = l$  if and only if  $i = j$ . Note that the invariance by permutation implies

$$\phi_k(w) = \phi_i(w_{\pi_1}, \dots, w_{\pi_m}).$$

Hence, it follows that

$$\frac{\partial \phi_k}{\partial w_\ell}(w) = \frac{\partial \phi_i}{\partial w_j}(w_{\pi_1}, \dots, w_{\pi_m})$$

and if we consider  $w$  in  $\mathcal{D}$ , this implies

$$\begin{aligned}\frac{\partial \phi_k}{\partial w_\ell}(w) &= \frac{\partial \phi_i}{\partial w_j}(w), i \neq j, k \neq \ell \\ \frac{\partial \phi_j}{\partial w_j}(w) &= \frac{\partial \phi_i}{\partial w_i}(w)\end{aligned}$$

By denoting  $e = (e_2, \dots, e_m)$  with  $e_i = w_i - w_1$ ,  $i = 2, \dots, m$  and  $x = w_1$ , we obtain an  $(e, x)$ -system of the type (1) with

$$F(e, x) = (F_i(e, x))_{i=2, \dots, m} \quad (43)$$

$$\begin{aligned}F_i(e, x) &= f(x + e_i) - f(x) \\ &\quad + g(x + e_i) \bar{\phi}_i(e, x) - g(x) \bar{\phi}_1(e, x),\end{aligned} \quad (44)$$

$$G(e, x) = f(x) + g(x) \bar{\phi}_1(e, x), \quad (45)$$

where we have used the notation

$$\bar{\phi}_i(e, x) = \phi_i(x, x + e_2, \dots, x + e_n)$$

Note that we have

$$|e|^2 \leq (m-1)|w|_{\mathcal{D}}^2, \quad (46)$$

and

$$\begin{aligned}|w|_{\mathcal{D}}^2 &\leq |e|^2 + (m-1) \left| \sum_{i=1}^m \frac{w_1 - w_i}{m} \right|^2 \\ &\leq \left( 1 + \frac{m-1}{m^2} \right) |e|^2\end{aligned} \quad (47)$$

Hence, (40) implies for all  $(e, x)$  with  $|e| \leq \frac{mr_w}{\sqrt{m^2+m-1}}$

$$|E(e, x, t)| \leq \sqrt{(m-1) \left( 1 + \frac{m-1}{m^2} \right)} k \exp(-\lambda t) |e|,$$

It follows from the assumptions of the proposition that Property TULES-NL is satisfied with  $r = \frac{mr_w}{\sqrt{m^2+m-1}}$  and that inequalities (13) and (14) hold. We conclude with Proposition 1 that Property UES-TL is satisfied also. So, in particular, there exist positive real numbers  $\tilde{k}$  and  $\tilde{\lambda}$  such that any  $e_i$  component of  $(\tilde{E}(\tilde{e}_0, \tilde{x}_0, t), \tilde{X}(\tilde{x}_0, t))$  solution of (6) satisfies, for all  $(\tilde{e}_0, \tilde{x}_0, t)$  in  $\mathbb{R}^{mn} \times \mathbb{R}^{mn} \times \mathbb{R}_{\geq 0}$ ,

$$|\tilde{E}_i(\tilde{e}_0, \tilde{x}, t)| \leq \tilde{k} \exp(-\tilde{\lambda} t) |\tilde{e}_0|. \quad (48)$$

On another hand, with (39), we obtain :

$$\frac{\partial F_i}{\partial e_i}(0, \tilde{x}) = \frac{\partial f}{\partial x}(\tilde{x}) + g(\tilde{x}) \left[ \frac{\partial \bar{\phi}_i}{\partial e_i}(0, \tilde{x}) - \frac{\partial \bar{\phi}_1}{\partial e_i}(0, \tilde{x}) \right]. \quad (49)$$

And, when  $j \neq i$ , it yields

$$\frac{\partial F_i}{\partial e_j}(0, \tilde{x}) = g(\tilde{x}) \left[ \frac{\partial \bar{\phi}_i}{\partial e_j}(0, \tilde{x}) - \frac{\partial \bar{\phi}_1}{\partial e_j}(0, \tilde{x}) \right] = 0. \quad (50)$$

Consequently, any solution of the system

$$\dot{\tilde{e}}_i = \left[ \frac{\partial f}{\partial x}(\tilde{x}) + g(\tilde{x}) \left[ \frac{\partial \bar{\phi}_i}{\partial e_i}(0, \tilde{x}) - \frac{\partial \bar{\phi}_1}{\partial e_i}(0, \tilde{x}) \right] \right] \tilde{e}_i ,$$

and  $\dot{\tilde{x}} = f(\tilde{x})$  can be expressed as an  $e_i$  component of  $(\tilde{E}(\tilde{e}_0, \tilde{x}_0, t), \tilde{X}(\tilde{x}_0, t))$  solution of (6) Since these solutions satisfy (48), Property Q1 does hold.

Finally we consider the system with state  $(e_i, x)$  in  $\mathbb{R}^{2n}$

$$\dot{e}_i = \bar{F}_i(e_i, x) , \quad \dot{x} = G(e_i, x) = f(x) \quad (51)$$

with  $\bar{F}_i(e_i, x) = F_i((0, e_i, 0), x)$ . The previous property and Proposition 2 imply that Property ULMTE is satisfied for system (51). So in particular we have a function  $P$  satisfying the properties in Q2 and such that we have, for all  $(v, x)$  in  $\mathbb{R}^n \times \mathbb{R}^n$ ,

$$\begin{aligned} v' \mathfrak{d}_f P(\tilde{x}) v & \\ & + 2v' P(\tilde{x}) \left( \frac{\partial f}{\partial x}(\tilde{x}) + g(\tilde{x}) \left[ \frac{\partial \bar{\phi}_i}{\partial e_i}(0, \tilde{x}) - \frac{\partial \bar{\phi}_1}{\partial e_i}(0, \tilde{x}) \right] \right) v \\ & \leq -v' Q v \end{aligned}$$

which implies (42) when  $v' P(x) g(x) = 0$ .  $\square$

**Example 2:** As an illustrative example consider the case in which the system is given by  $m$  agents  $w_i$  in  $\mathbb{R}^2$  with individual dynamics

$$\dot{w}_{i1} = w_{i2} + 2 \sin(w_{i2}) , \quad \dot{w}_{i2} = a + u_i , \quad (52)$$

where  $a$  is a real number. Because of a singularity when  $1 + 2 \cos(w_{i2}) = 0$ , this system is not feedback linearizable per se. Hence the design of a synchronizing controller may be involved.

In order to check if local synchronization in the sense of Definition 1 is possible, the necessary conditions of Proposition 5 may be tested. The transversally linear system is

$$\dot{\tilde{e}} = \begin{bmatrix} 0 & 1 + 2 \cos(x_0 + at) \\ 0 & 0 \end{bmatrix} \tilde{e} + \begin{bmatrix} 0 \\ 1 \end{bmatrix} u . \quad (53)$$

When  $a = 0$  and  $x_0 = \frac{2\pi}{3}$ , this system is not stabilizable by any feedback law. Hence in this case, with Proposition 5, there is no exponentially synchronizing control law in the sense of Definition 1 satisfying (39) in particular.

Similar to the analysis of incremental stability in the previous section and observer design in [27], by using a function  $P$  satisfying the property Q2 in Proposition 5, we can obtain sufficient conditions for the solvability of uniform exponential synchronization of (38).

We do this under an extra assumption which is that, up to a scaling factor, the control vector field  $g$  is a gradient field with  $P$  as Riemannian metric.

**Proposition 6** (Local sufficient condition). Assume  $f$  has bounded first and second derivatives, and  $g$  is bounded and has bounded first and second derivatives. Moreover, assume that

1. there exist a  $C^2$  function  $U : \mathbb{R}^n \rightarrow \mathbb{R}$  and a bounded  $C^2$  function  $\alpha : \mathbb{R}^n \rightarrow \mathbb{R}^p$  which has bounded first and second derivative such that

$$\frac{\partial U}{\partial x}(x)' = P(x) g(x) \alpha(x) ; \quad (54)$$

holds for all  $x$  in  $\mathbb{R}^n$ ; and

2. there exist a positive definite matrix  $Q$ , a  $C^2$  function  $P : \mathbb{R}^n \rightarrow \mathbb{R}^{n \times n}$  with bounded derivative, and positive real numbers  $\underline{p}$ ,  $\bar{p}$  and  $\rho > 0$  such that (19) is satisfied and

$$v' \mathfrak{d}_f P(x)v + 2v' P(x) \frac{\partial f}{\partial x}(x)v - \rho \left| \frac{\partial U}{\partial x}(x)v \right|^2 \leq -v' Qv, \quad (55)$$

holds for all  $(x, v)$  in  $\mathbb{R}^n \times \mathbb{R}^n$ .

Then there exist a real number  $\underline{\ell}$  such that with the control laws  $u_i = \phi_i(w)$  given by

$$\phi_i(w) = \ell \alpha(w_i) \left[ \sum_{j=1}^m \frac{U(w_j)}{m} - U(w_i) \right] \quad (56)$$

and  $\ell \geq \underline{\ell}$  and if the closed loop system is complete then the local uniform exponential synchronization of (38) is solved.

Note that, for its implementation, the control law (56) requires that each agent  $i$  communicates  $U(w_i)$  to all the other agents.

*Proof :* First of all, note that the control law  $\phi_i$  is invariant by permutation due to its structure. Let  $e = (e_2, \dots, e_m)$  with  $e_i = x_1 - x_i$  and  $x = x_1$ . We obtain an  $(e, x)$ -system of the type (1) with  $F$  and  $G$  as defined in (43-44-45) with  $\phi$  as control input. For this system, we will show that property ULMTE is satisfied. Consider the function  $P_m : \mathbb{R}^n \rightarrow \mathbb{R}^{(m-1)n \times (m-1)n}$  defined as a block diagonal matrix composed of  $(m-1)$  matrices  $P$ . i.e.  $P_m(x) = \text{Diag}(P(x), \dots, P(x))$ . Note that with property (49) and (50), it yields that  $\frac{\partial F}{\partial e}(0, \tilde{x})$  is also  $(m-1)$  block diagonal. Hence, we have

$$\mathfrak{d}_{\tilde{G}} P_m(\tilde{x}) + P_m(\tilde{x}) \frac{\partial F}{\partial e}(0, \tilde{x}) + \frac{\partial F}{\partial e}(0, \tilde{x})' P_m(\tilde{x}) = \text{Diag}\{R(\tilde{x}), \dots, R(\tilde{x})\}$$

where

$$R(\tilde{x}) = \mathfrak{d}_f P(\tilde{x})v + P(\tilde{x}) \left[ \frac{\partial f}{\partial x}(\tilde{x}) - \ell g(\tilde{x}) \alpha(\tilde{x}) \frac{\partial U}{\partial x}(\tilde{x}) \right] + \left[ \frac{\partial f}{\partial x}(\tilde{x}) - \ell g(\tilde{x}) \alpha(\tilde{x}) \frac{\partial U}{\partial x}(\tilde{x}) \right]' P(\tilde{x}).$$

With (55), this gives

$$v' R(\tilde{x})v \leq -v' Qv + (k-2\ell) \left| \frac{\partial U}{\partial x}(\tilde{x})v \right|^2.$$

for all  $(\tilde{x}, v)$  in  $\mathbb{R}^n \times \mathbb{R}^n$ . Hence, picking  $\ell > \frac{k}{2}$ , inequality (9) holds. To apply proposition 3, it remains to show that inequalities (15), (17) and (18) are satisfied. Note that employing the bounds on the functions  $P$ ,  $f$ ,  $g$ ,  $\alpha$  and there derivatives, it is possible to get a positive real number  $\tilde{c}$



(depending on  $\ell$ ) such that for all  $i$  in  $2, \dots, m$  and all  $(e, x)$

$$\begin{aligned} \left| \frac{\partial F_i}{\partial e_i}(e, x) \right| &\leq \tilde{c} \left| \sum_{j=1}^m \frac{U(x + e_j)}{m} - U(x + e_i) \right| + \tilde{c}, \\ \left| \frac{\partial F_i}{\partial e_i \partial x}(e, x) \right| &\leq \tilde{c} \left| \sum_{j=1}^m \frac{U(x + e_j)}{m} - U(x + e_i) \right| + \tilde{c}, \\ \left| \frac{\partial F_i}{\partial e_i \partial e_j}(e, x) \right| &\leq \tilde{c} \left| \sum_{j=1}^m \frac{U(x + e_j)}{m} - U(x + e_i) \right| + \tilde{c}, \\ \left| \sum_{j=1}^m \frac{U(x + e_j)}{m} - U(x + e_i) \right| &\leq \tilde{c}|e|, \quad \forall (e, x) \end{aligned}$$

So we fix  $\eta$  positive and pick  $c = \tilde{c}^2 \eta + \tilde{c}$ . The above shows that inequalities (17) and (18) are satisfied. With Proposition 3, we conclude that Property TULES-NL holds. Hence  $e = 0$  is (locally) exponentially stable manifold. With inequalities (46) and (47) this implies that inequality (40) holds.  $\square$

In this result it is important to remark that there is no guarantee that the control law given here ensures completeness of the solution. Note however, that on the manifold  $|w|_{\mathcal{D}} = 0$ , the trajectories satisfy  $\dot{x} = f(x)$  which is a complete system

**Example 2 (continued):** We come back to the example (52) in the case where  $a = 1$ . We note that the linear system (53) is stabilizable by a feedback in the form

$$u = -(1 + 2(\cos(x_0 + t))) \begin{bmatrix} 2 & 3 \end{bmatrix} \tilde{e}$$

Indeed, the solution of (53) with the previous feedback satisfies

$$\dot{\tilde{e}} = (1 + \cos(x_0 + t)) \begin{bmatrix} 0 & 1 \\ -2 & -3 \end{bmatrix} \tilde{e}.$$

Hence its solution are  $\tilde{E}(e, x, t) = \psi(x, t)\tilde{e}$ , where  $\psi$  is the generator of this time varying linear system given as

$$\begin{aligned} \psi(x, t) &= \exp \left( (t + 2 \sin(x + t)) \begin{bmatrix} 0 & 1 \\ -2 & -3 \end{bmatrix} \right) \\ &= \varphi(x, t)^{-2} \begin{bmatrix} -1 + 2\varphi(x, t) & -1 + \varphi(x, t) \\ 2(1 - \varphi(x, t)) & 2 - \varphi(x, t) \end{bmatrix} \end{aligned}$$

with  $\varphi(x, t) = e^{t+2 \sin(t+x)}$ .

Consequently, we get that  $\tilde{e}$  goes exponentially to zero. Hence Property  $Q_1$  is satisfied.

We can then introduce the matrix  $P$  solution to  $Q_2$  and given in (16) as

$$P(x) = \int_0^{+\infty} \psi(x, s)' \psi(x, s) ds. \quad (57)$$

This matrix is positive definite and satisfies property Q2. So we may want to use it for designing an exponentially synchronizing control law. With decomposing the  $2 \times 2$  matrix  $P$  as

$$P(w_i) = \begin{bmatrix} P_{11}(w_{i2}) & P_{12}(w_{i2}) \\ P_{12}(w_{i2}) & P_{22}(w_{i2}) \end{bmatrix},$$

we obtain  $P(w)g(w) = [P_{12}(w_{i2}) \quad P_{22}(w_{i2})]'$ . Note that it can be shown (numerically) that

$$P_{12}(w_{i2}) = \int_0^\infty \frac{4}{\varphi(w_{i2}, t)^2} - \frac{9}{\varphi(w_{i2}, t)^3} + \frac{5}{\varphi(w_{i2}, t)^4} dt > 0.$$

It follows that the function  $\alpha(w) = \frac{1}{P_{12}(w_{i2})}$  is well defined and setting

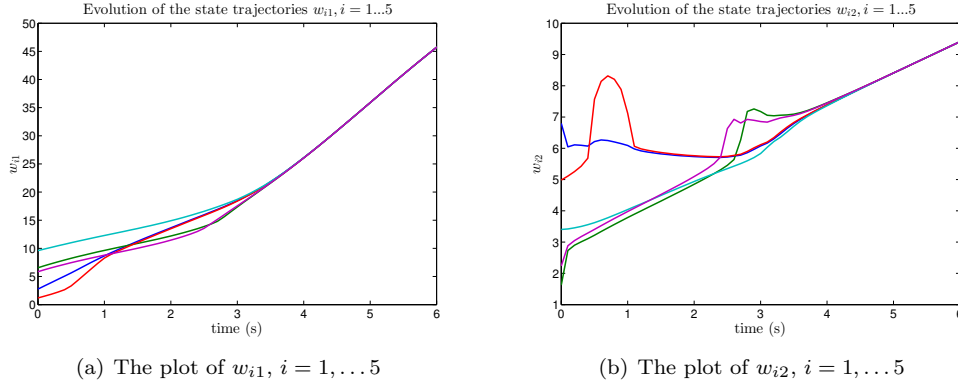


Figure 1: Numerical simulation results of the interconnected five agents as considered in Example 1. The left-figure shows the trajectories of the first state variable of each agent,  $w_{i1}$ ,  $i = 1 \dots 5$  while the right-figure shows those of the second state variable of each agent  $w_{i2}$ ,  $i = 1 \dots 5$ . The simulation results show that the proposed contraction-based distributed control law is able to synchronize the states  $w_i$ ,  $i = 1 \dots 5$ .

$$U(w_i) = w_{i1} + \int_0^{w_{i2}} \frac{P_{22}(s)}{P_{12}(s)} ds$$

property (54) is satisfied. Hence, for this example, picking  $\ell$  a sufficiently large real number, the control law (56) ensures local exponential synchronization of  $m$  agents. We have checked this via simulation for the case  $m = 5$ ,  $\ell = 3$ . The time evolution of the solution with  $w_i(0)$ ,  $i = 1, \dots, 5$  chosen randomly according to a uniform distribution on  $[0, 10]$  is shown in Figure 1a for  $w_{i1}$  and 1b for  $w_{i2}$ .

As in the context of the observer design given in [27], a global result can be obtained by imposing a further constraint on  $P$ . Specifically, the notion we need to introduce is the following.

**Definition 2** (Totally Geodesically Set). *Given a  $C^2$  function  $P$  defined on  $\mathbb{R}^n$  the values of which are symmetric positive definite matrices, a  $C^1$  function  $\varphi : \mathbb{R}^n \rightarrow \mathbb{R}_+$  and a real number  $\bar{\varphi}$ , the (level) set  $S = \{x \in \mathbb{R}^n, \varphi(x) = \bar{\varphi}\}$  is said to be totally geodesic with respect to  $P$  if, for any  $(x, v)$  in  $S \times \mathbb{R}^n$  such that*

$$\frac{\partial \varphi}{\partial x}(x)v = 0, v'P(x)v = 1,$$

any geodesic  $\gamma$ , i.e. a solution of

$$\begin{aligned} \frac{d}{ds} \left( \frac{d\gamma^*}{ds}(s)' P(\gamma^*(s)) \right) l & \\ &= \frac{1}{2} \frac{\partial}{\partial x} \left( \frac{d\gamma^*}{ds}(s)' P(x) \frac{d\gamma^*}{ds}(s) \right) \Big|_{x=\gamma^*(s)}, \end{aligned} \quad (58)$$

with  $\gamma(0) = x$  and  $\frac{d\gamma}{ds}(0) = v$  satisfies

$$\frac{\partial \varphi}{\partial x}(\gamma(s)) \frac{d\gamma}{ds}(s) = 0, \forall s.$$

For the case of two agents only, we have the following.

**Proposition 7** (Global sufficient condition for  $m = 2$ ). *Assume*

1. *there exist a  $C^3$  function  $U : \mathbb{R}^n \rightarrow \mathbb{R}$  which has bounded first and second derivatives, and a  $C^1$  function  $\alpha : \mathbb{R}^n \rightarrow \mathbb{R}^p$  such that, for all  $x$  in  $\mathbb{R}^n$ , (54) is satisfied;*
2. *there exist a positive real number  $\lambda$ , a  $C^3$  function  $P : \mathbb{R}^n \rightarrow \mathbb{R}^{n \times n}$  and positive real numbers  $\underline{p}$  and  $\bar{p}$ , such that inequalities (19) hold and we have, for all  $(x, v)$  in  $\mathbb{R}^n \times \mathbb{R}^n$  such that  $\frac{\partial U}{\partial x}(x)'v = 0$*

$$\frac{1}{2} v' \mathfrak{d}_f P(x) v + v' P(x) \frac{\partial f}{\partial x}(x) v \leq -\lambda v' P(x) v, \quad (59)$$

3. *For all  $\bar{U}$  in  $\mathbb{R}$ , the set  $S = \{x \in \mathbb{R}^n, U(x) = \bar{U}\}$  is totally geodesic with respect to  $P$ . Then there exists a function  $\ell : \mathbb{R}^{2n} \rightarrow \mathbb{R}_+$ , invariant by permutation such that, with the controls given by*

$$\phi_i(w) = \ell(w) \alpha(w_i) (U(w_j) - U(w_i)),$$

with  $(i, j) \in \{(1, 2), (2, 1)\}$  the following holds and for all  $w$  in  $\mathbb{R}^{2n}$ ,

$$|W(w, t)|_{\mathcal{D}} \leq k |w|_{\mathcal{D}} \exp\left(-\frac{\lambda}{2} t\right), \quad (60)$$

where  $t$  is any positive real number in the time domain of definition of the closed loop solution.

The proof of this result is given in Appendix .4. It borrows some ideas of [27]. However, different from [27], we have here a global convergence result. This follows from the fact that in the high gain parameter  $\ell$ , the norm of the full state space can be used (and not only the norm of the estimate as in the observer case).

Note that nothing is said about the domain of existence of the solution.

## 4 Conclusion

We have studied the relationship between the exponential stability of an invariant manifold and the existence of a Riemannian metric for which the flow is “transversally” contracting. It was shown that the following properties are equivalent

1. A manifold is “transversally” exponentially stable;
2. The “transverse” linearization along any solution in the manifold is exponentially stable;

3. There exists a field of positive definite quadratic forms whose restrictions to the transverse direction to the manifold are decreasing along the flow.

As an illustrative example for these equivalence results, we have revisited the property of exponential incremental stability where we can obtain a global result.

The characterization of transverse exponential stability has allowed us to investigate a necessary condition for two different control problems of nonlinear observer design and of synchronization of nonlinear multi-agent systems which leads to a novel constructive design for each problem. Recent result by others has also shown the applicability of our results beyond these two control problems. Although the main results hold for local uniform transverse exponential stability, we show that global results can also be obtained in some particular cases. The extension of all the results to the global case is currently under study.

### .1 Proof of Proposition 1

*Proof* : Let us start with some estimations. Let  $z = e - \tilde{e}$ . Along solutions of (1) and (6), we have

$$\dot{z} = F(e, x) - \frac{\partial F}{\partial e}(0, \tilde{x})\tilde{e} = \frac{\partial F}{\partial e}(0, \tilde{x})z + \Delta(e, x, \tilde{x})$$

with the notation

$$\begin{aligned} \Delta(e, x, \tilde{x}) &= F(e, x) - \frac{\partial F}{\partial e}(0, \tilde{x})e, \\ &= [F(e, x) - F(e, \tilde{x})] \\ &\quad + \left[ F(e, \tilde{x}) - F(0, \tilde{x}) - \frac{\partial F}{\partial e}(0, \tilde{x})e \right]. \end{aligned}$$

Note that the manifold  $\mathcal{E} := \{(e, x) : e = 0\}$  being invariant, it yields

$$F(0, x) = 0 \quad \forall x. \quad (61)$$

With Hadamard's lemma, (61) and (14), we obtain the existence of positive real numbers  $c_1$  and  $c_2$  such that, for all  $(e, x, \tilde{x})$  in  $B_e(kr) \times \mathbb{R}^{n_x} \times \mathbb{R}^{n_x}$ ,

$$|\Delta(e, x, \tilde{x})| \leq c_1|e|^2 + c_2|e||x - \tilde{x}|.$$

This, with (15), gives, for all  $(e, \tilde{e}, x, \tilde{x})$  in  $B_e(kr) \times \mathbb{R}^{n_e} \times \mathbb{R}^{n_x} \times \mathbb{R}^{n_x}$ ,<sup>1</sup>

$$\widehat{|\dot{z}|} \leq \mu|z| + c_1|e|^2 + c_2|e||x - \tilde{x}|. \quad (62)$$

---

<sup>1</sup> Here the notation  $\widehat{|\dot{z}|}$  is abusive. The function  $x \mapsto |x|$  is not  $C^1$  but only Lipschitz. Nevertheless given a vector field  $f$  an upper right Dini Lie derivative, i.e.  $\limsup_{h \rightarrow 0_+} \frac{|x+hf(x)|-|x|}{h}$  does exist and, by the triangle inequality, we have

$$-|f(x)| \leq \limsup_{h \rightarrow 0_+} \frac{|x+hf(x)|-|x|}{h} \leq |f(x)|.$$

So here and in the following  $\widehat{|\dot{x}|}$  denotes this upper right Dini Lie derivative.

Similarly (1), (6) and (14) give, for all  $(e, x, \tilde{x})$  in  $B_e(kr) \times \mathbb{R}^{n_x} \times \mathbb{R}^{n_x}$ ,

$$\begin{aligned} \overline{|x - \tilde{x}|} & \leq |G(e, x) - G(0, x)| + |G(0, x) - G(0, \tilde{x})| , \\ & \leq c|e| + \rho|x - \tilde{x}| . \end{aligned} \tag{63}$$

Now let  $\tilde{r}$  be a positive real number smaller than  $r$  and  $S$  be a positive real number both to be made precise later on. Let  $\tilde{e}_0$  in  $B_e(\tilde{r})$  and  $\tilde{x}_0$  in  $\mathbb{R}^{n_x}$  be arbitrary and let  $(\tilde{E}(\tilde{e}_0, \tilde{x}_0, t), \tilde{X}(\tilde{x}_0, t))$  be the corresponding solution of (6). Because of the completeness assumption on (1), the linearity of (6) and the fact that  $(0, \tilde{X}(\tilde{x}_0, t))$  is solution of both (1) and (6),  $(\tilde{E}, \tilde{X})$  is defined on  $[0, +\infty)$ . We denote :

$$\tilde{e}_i = \tilde{E}(\tilde{e}_0, \tilde{x}_0, iS) , \quad \tilde{x}_i = \tilde{X}(\tilde{x}_0, iS) \quad \forall i \in \mathbb{N}^2$$

and consider the corresponding solutions  $(E(\tilde{e}_i, \tilde{x}_i, s), X(\tilde{e}_i, \tilde{x}_i, s))$  of (1). By assumption, they are defined on  $[0, +\infty)$  and, because of (4), if  $\tilde{e}_i$  is in  $B_e(r)$ , then  $E(\tilde{e}_i, \tilde{x}_i, s)$  is in  $B_e(kr)$  for all positive times  $s$ , making possible the use of inequalities (62) and (63). Finally, for each integer  $i$ , we define the following time functions on  $[0, S]$

$$\begin{aligned} Z_i(s) & = |E(\tilde{e}_i, \tilde{x}_i, s) - \tilde{E}(\tilde{e}_0, \tilde{x}_0, s + iS)| , \\ W_i(s) & = |X(\tilde{e}_i, \tilde{x}_i, s) - \tilde{X}(\tilde{x}_0, s + iS)| . \end{aligned}$$

Note that we have  $Z_i(0) = W_i(0) = 0$ .

From the inequalities (63), and (7), we get, for each integer  $i$  such that  $\tilde{e}_i$  is in  $B_e(r)$ , and for all  $s$  in  $[0, S]$ ,

$$\begin{aligned} W_i(s) & \leq c \int_0^s \exp(\rho(s - \sigma)) |E(\tilde{e}_i, \tilde{x}_i, \sigma)| d\sigma , \\ & \leq c \int_0^s \exp(\rho(s - \sigma)) k \exp(-\lambda\sigma) d\sigma |\tilde{e}_i| , \\ & \leq ck \exp(-\lambda s) \frac{\exp((\rho + \lambda)s) - 1}{\rho + \lambda} |\tilde{e}_i| . \end{aligned}$$

Similarly, using (62) and Grönwall inequality we get

$$\begin{aligned} Z_i(s) & \leq c \int_0^s \exp(\mu(s - \sigma)) |E(\tilde{e}_i, \tilde{x}_i, \sigma)| (|E(\tilde{e}_i, \tilde{x}_i, \sigma)| + W_i(\sigma)) d\sigma \\ & \leq \gamma(s) |\tilde{e}_i|^2 \quad \forall s \in [0, S] , \end{aligned}$$

where we have used the notation,

$$\begin{aligned} \gamma(s) & = c \int_0^s \exp(\mu(s - \sigma)) k \exp(-2\lambda\sigma) \times \\ & \quad \times \left( k + ck \exp(-\lambda\sigma) \frac{\exp((\rho + \lambda)\sigma) - 1}{\rho + \lambda} \right) d\sigma . \end{aligned}$$

With all this, we have obtained that, if we have  $\tilde{e}_j$  in  $B_e(r)$  for all  $j$  in  $\{0, \dots, i\}$ , then we have also,

for all  $s$  in  $[0, S]$  and all  $j$  in  $\{0, \dots, i\}$ ,

$$\begin{aligned} |\tilde{E}(\tilde{e}_0, \tilde{x}_0, s + jS)| &= |\tilde{E}(\tilde{e}_j, \tilde{x}_j, s)|, \\ &\leq |E(\tilde{e}_j, \tilde{x}_j, s)| + |Z_j(s)|, \\ &\leq \left[ k \exp(-\lambda s) + \gamma(s) |\tilde{e}_j| \right] |\tilde{e}_j| \end{aligned}$$

Now, given a real number  $\varepsilon$  in  $(0, 1)$ , we select  $S$  and  $\tilde{r}$  to satisfy :

$$\begin{aligned} k \exp(-\lambda S) &\leq \frac{\min\{k, 1 - \varepsilon\}}{2}, \\ \tilde{r} &\leq \min \left\{ r, \frac{\min\{k, 1 - \varepsilon\}}{2 \sup_{s \in [0, S]} \gamma(s)} \right\}. \end{aligned}$$

Then, for all  $\tilde{e}_j$  smaller in norm than  $\tilde{r}$ , we have

$$|\tilde{E}(\tilde{e}_0, \tilde{x}_0, s + jS)| \leq (1 - \varepsilon) |\tilde{e}_j|$$

So, since  $\tilde{e}_0$  is in  $B_e(\tilde{r})$ , it follows by induction that we have :

$$|\tilde{e}_i| = |\tilde{E}(\tilde{e}_0, \tilde{x}_0, iS)| \leq (1 - \varepsilon)^i \tilde{r} \leq \tilde{r} \quad \forall i \in \mathbb{N}.$$

Since, with (15), we have also  $\dot{|\tilde{e}|} \leq \mu |\tilde{e}|$ , we have established, for all  $s$  in  $[0, S]$  and all  $i$  in  $\mathbb{N}$ ,

$$|\tilde{E}(\tilde{e}_0, \tilde{x}_0, s + iS)| \leq \exp(\mu s) (1 - \varepsilon)^i |\tilde{e}_0|$$

and therefore, for all  $(\tilde{e}_0, \tilde{x}_0, t)$  in  $B_e(a) \times \mathbb{R}^{n_x} \times \mathbb{R}_{\geq 0}$ ,

$$|\tilde{E}(\tilde{e}_0, \tilde{x}_0, t)| \leq \exp(\mu S) (1 - \varepsilon)^{\frac{t-S}{S}} |\tilde{e}_0|.$$

By rearranging this inequality and taking advantage of the homogeneity of the system (6) in the  $\tilde{e}$  component, we have obtained (7) with  $\tilde{k} = \frac{\exp(\mu S)}{1 - \varepsilon}$  and  $\tilde{\lambda} = -\frac{\ln(1 - \varepsilon)}{S}$ .  $\square$

## .2 Proof of Proposition 2

*Proof :* Let  $(\tilde{E}(\tilde{e}_0, \tilde{x}_0, t), \tilde{X}(\tilde{x}_0, t))$  be the solution of (6) passing through an arbitrary pair  $(\tilde{e}_0, \tilde{x}_0)$  in  $\mathbb{R}^{n_e} \times \mathbb{R}^{n_x}$ . By assumption, it is defined on  $[0, +\infty)$ .

For any  $v$  in  $\mathbb{R}^{n_e}$ , we have

$$\frac{\partial}{\partial t} \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t) v \right) = \frac{\partial F}{\partial e}(0, \tilde{X}(\tilde{x}_0, t)) \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t) v.$$

Uniqueness of solutions then implies, for all  $(\tilde{e}_0, \tilde{x}_0, t)$  in  $\mathbb{R}^{n_e} \times \mathbb{R}^{n_x} \times \mathbb{R}_{\geq 0}$ ,  $\tilde{E}(\tilde{e}_0, \tilde{x}_0, t) = \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t) \tilde{e}_0$  and our assumption (7) gives, for all  $(\tilde{e}_0, \tilde{x}_0, t)$  in  $\mathbb{R}^{n_e} \times \mathbb{R}^{n_x} \times \mathbb{R}_{\geq 0}$ ,

$$\left| \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t) \tilde{e}_0 \right| \leq \tilde{k} |\tilde{e}_0| \exp(-\tilde{\lambda} t)$$

and therefore

$$\left| \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t) \right| \leq \tilde{k} \exp(-\tilde{\lambda}t) \quad \forall (\tilde{x}_0, t) \in \mathbb{R}^{n_x} \times \mathbb{R}_{\geq 0} .$$

This allows us to claim that, for every symmetric positive definite matrix  $Q$ , the function  $P : \mathbb{R}^{n_x} \rightarrow \mathbb{R}^{n_e \times n_e}$  given by (16) is well defined, continuous and satisfies

$$\lambda_{\max}\{P(\tilde{x})\} \leq \frac{\tilde{k}^2}{2\tilde{\lambda}} \lambda_{\max}\{Q\} = \bar{p} \quad \forall \tilde{x} \in \mathbb{R}^{n_x} .$$

Moreover we have

$$\begin{aligned} \frac{\partial}{\partial t} \left( v' \left[ \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t) \right]^{-1} \right) \\ = -v' \left[ \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t) \right]^{-1} \frac{\partial F}{\partial e}(0, \tilde{X}(\tilde{x}_0, t)) , \end{aligned}$$

With (15), this yields

$$\left| v' \left[ \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t) \right]^{-1} \right| \leq \exp(\mu t) |v|$$

and implies

$$\begin{aligned} [v'v]^2 \\ \leq \left| v' \left[ \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t) \right]^{-1} \right|^2 \left| \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t)v \right|^2 \\ \leq \frac{1}{\lambda_{\min}\{Q\}} \left| v' \left[ \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t) \right]^{-1} \right|^2 \times \\ \quad \times v' \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t)' Q \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t)v \\ \leq \frac{|v|^2 \exp(2\mu t)}{\lambda_{\min}\{Q\}} v' \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t)' Q \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}_0, t)v \end{aligned}$$

This gives

$$\underline{p} = \frac{1}{2\mu} \lambda_{\min}\{Q\} \leq \lambda_{\min}\{P(\tilde{x})\} \quad \forall \tilde{x} \in \mathbb{R}^{n_x} .$$

Finally, to get (9), let us exploit the semi group property of the solutions. We have for all  $(\tilde{e}, \tilde{x})$  in  $\mathbb{R}^{n_x} \times \mathbb{R}^{n_e}$  and all  $(t, r)$  in  $\mathbb{R}_{\geq 0}^2$

$$\tilde{E}(\tilde{E}(\tilde{e}, \tilde{x}, t), \tilde{X}(\tilde{x}, t), r) = \tilde{E}(\tilde{e}, \tilde{x}, t+r) .$$

Differentiating with respect to  $\tilde{e}$  the previous equality yields

$$\frac{\partial \tilde{E}}{\partial \tilde{e}}(\tilde{E}(\tilde{e}, \tilde{x}, t), \tilde{X}(\tilde{x}, t), r) \frac{\partial \tilde{E}}{\partial \tilde{e}}(\tilde{e}, \tilde{x}, t) = \frac{\partial \tilde{E}}{\partial \tilde{e}}(\tilde{e}, \tilde{x}, t+r)$$

Setting in the previous equality

$$(\tilde{e}, \tilde{x}) := (0, \tilde{X}(\tilde{x}, h)), \quad h := -t, \quad s := t + r$$

we get for all  $\tilde{x}$  in  $\mathbb{R}^{n_x}$  and all  $(s, h)$  in  $\mathbb{R}^2$

$$\frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s + h) \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{X}(\tilde{x}, h), -h) = \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{X}(\tilde{x}, h), s).$$

Consequently, this yields,

$$\begin{aligned} P(\tilde{X}(\tilde{x}, h)) &= \lim_{T \rightarrow +\infty} \int_0^T \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{X}(\tilde{x}, h), s) \right)' Q \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{X}(\tilde{x}, h), s) ds \\ &= \lim_{T \rightarrow +\infty} \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{X}(\tilde{x}, h), -h) \right) \times \\ &\quad \times \left[ \int_0^T \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s + h) \right)' Q \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s + h) ds \right] \times \\ &\quad \times \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{X}(\tilde{x}, h), -h) \end{aligned}$$

But we have :

$$\begin{aligned} \lim_{h \rightarrow 0} \frac{\frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{X}(\tilde{x}, h), -h) - I}{h} &= -\frac{\partial F}{\partial e}(0, \tilde{x}), \\ \lim_{h \rightarrow 0} \frac{\frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s + h) - \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s)}{h} &= \frac{\partial}{\partial s} \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s) \right) \end{aligned}$$

and

$$\begin{aligned} \int_0^T \frac{\partial}{\partial s} \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s) \right)' Q \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s) \right) ds \\ + \int_0^T \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s) \right)' Q \frac{\partial}{\partial s} \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s) \right) ds \\ = \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, T) \right)' Q \left( \frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, T) \right) - Q. \end{aligned}$$

Since  $\lim_T$  and  $\lim_h$  commute because of the exponential convergence to 0 of  $\frac{\partial \tilde{E}}{\partial \tilde{e}}(0, \tilde{x}, s)$ , we conclude that the derivative (8) does exist and satisfies (9).  $\square$

### .3 Proof of Proposition 3

*Proof* : Consider the function  $V(e, x) = e' P(x) e$ . Using (9), the time derivative of  $V$  along the solutions of the system (1) is given, for all  $(e, x)$ , by



$$\begin{aligned}
\overline{V(e, x)} &= 2e'P(x)F(e, x) + \frac{\partial e'P(\cdot)e}{\partial x}(x)G(e, x) \\
&\leq -e'Qe + 2e'P(x) \left[ F(e, x) - \frac{\partial F}{\partial e}(0, x)e \right] \\
&\qquad\qquad\qquad + \frac{\partial e'P(\cdot)e}{\partial x}(x) [G(e, x) - G(0, x)] .
\end{aligned}$$

On the other hand, using Hadamard's Lemma and (18), we get :

$$\begin{aligned}
\left| F(e, x) - \frac{\partial F}{\partial e}(0, x)e \right| &\leq c|e|^2 , \\
|G(e, x) - G(0, x)| &\leq c|e| \quad \forall (e, x) \in B_e(\eta) \times \mathbb{R}^{n_x} .
\end{aligned}$$

These inequalities together with (10) and (17) imply, for all  $(e, x)$  in  $B_e(\eta) \times \mathbb{R}^{n_x}$ ,

$$\overline{V(e, x)} \leq - \left[ \frac{\lambda_{\min}\{Q\}}{\underline{p}} - 2c(1+c)\frac{\bar{p}}{\underline{p}}|e| \right] V(e, x) .$$

It shows immediately that (4) holds with  $r$ ,  $k$  and  $\lambda$  satisfying :

$$\begin{aligned}
r &< \frac{\underline{p}}{\bar{p}} \min \left\{ \eta, \frac{\lambda_{\min}\{Q\}}{2\bar{p}c(1+c)} \right\} , \\
k &= \sqrt{\frac{\bar{p}}{\underline{p}}} , \\
\lambda &= \left[ \frac{\lambda_{\min}\{Q\}}{2\bar{p}} - rc(1+c)\frac{\bar{p}}{\underline{p}} \right] .
\end{aligned}$$

□

#### 4 Proof of Proposition 7

The result holds when  $w$  is in  $\mathcal{D}$  or when  $U$  is constant (since (59) holds for all  $v$ ). So, in view of [27, Proposition A.2.1], we can assume without loss of generality that  $\frac{\partial U}{\partial w}$  has nowhere a zero norm and, in the following, we restrict our attention to  $\mathbb{R}^{2n} \setminus \mathcal{D}$ . In  $\mathbb{R}^{2n} \setminus \mathcal{D}$  the dynamics of  $w$  is

$$\dot{w}_i = f(w_i) + \ell(w)g(w_i)\alpha(w_i) \sum_{j=1}^2 [U(w_j) - U(w_i)]$$

With the  $C^2$  matrix function  $P$  we define the Riemannian length of a piece-wise  $C^1$  path  $\gamma : [s_1, s_2] \rightarrow \mathbb{R}^n$ , between  $w_1 = \gamma(s_1)$  and  $w_2 = \gamma(s_2)$  as in (20) and the corresponding distance  $d(w_1, w_2)$  by minimizing along all such path

Because of (19) and the fact that  $P$  is  $C^3$ , Hopf-Rinow Theorem implies the metric space we obtain this way is complete, and, given any  $w_1$  in  $\mathbb{R}^n$  and  $w_2$  in  $\mathbb{R}^n$ , there exists a  $C^3$  normalized<sup>3</sup> minimal geodesic  $\gamma^*$ , solution of (58), such that

$$\begin{aligned}
w_1 &= \gamma^*(s_1) , \quad w_2 = \gamma^*(s_2) , \\
d(w_1, w_2) &= L(\gamma^*) \Big|_{s_1}^{s_2} = s_2 - s_1 .
\end{aligned} \tag{64}$$

---

<sup>3</sup>This means that  $\gamma^*$  satisfies  $\frac{d\gamma^*}{ds}(s)'P(\gamma^*(s))\frac{d\gamma^*}{ds}(s) = 1$ .

Following [27], for each  $s$  in  $[s_1, s_2]$  consider the  $C^1$  function  $t \mapsto \Gamma(s, t)$  solution of

$$\begin{aligned} \frac{\partial \Gamma}{\partial t}(s, t) &= f(\Gamma(s, t)) \\ &+ \ell(W(w, t)) g(\Gamma(s, t)) \alpha(\Gamma(s, t)) \times \\ &\quad \times \sum_{j=1}^2 [U(W_j(w, t)) - U(\Gamma(s, t))] \end{aligned}$$

with initial condition

$$\Gamma(s, 0) = \gamma^*(s). \quad (65)$$

With (39), we have

$$\Gamma(s_1, t) = W_1(w, t), \quad \Gamma(s_2, t) = W_2(w, t)$$

and so, for each  $t$ ,  $s \in [s_1, s_2] \mapsto \Gamma(s, t)$  is a  $C^2$  path between  $W_1(w, t)$  and  $W_2(w, t)$ . From the first variation formula (see [31, Theorem 6.14] for instance<sup>4</sup>), we have

$$\frac{d}{dt} \left( L(\Gamma(s, t)) \Big|_{s_1}^{s_2} \right) \Big|_{t=0} = A(w) + C(w)$$

where

$$\begin{aligned} A(w) &= \ell(w) [U(w_1) - U(w_2)] \frac{d\gamma^*}{ds}(s_2)' P(w_2) g(w_2) \alpha(w_2) \\ &\quad - \ell(w) [U(w_2) - U(w_1)] \frac{d\gamma^*}{ds}(s_1)' P(w_1) g(w_1) \alpha(w_1) \end{aligned}$$

$$C(w) = \frac{d\gamma^*}{ds}(s_2)' P(w_2) f(w_2) - \frac{d\gamma^*}{ds}(s_1)' P(w_1) f(w_1)$$

But, with (54), we obtain :

$$\begin{aligned} A(w) &= -\ell(w) [U(w_2) - U(w_1)] \times \\ &\quad \times \left[ \frac{\partial U}{\partial x}(w_2) \frac{d\gamma^*}{ds}(s_2) + \frac{\partial U}{\partial x}(w_1) \frac{d\gamma^*}{ds}(s_1) \right] \end{aligned}$$

Also, with the Euler-Lagrange form of the geodesics equation (58), we get :

$$\begin{aligned} C(w) &= \int_{s_1}^{s_2} \left[ \frac{d}{ds} \left( \frac{d\gamma^*}{ds}(s)' P(\gamma^*(s)) \right) f(\gamma^*(s)) \right. \\ &\quad \left. + \frac{d\gamma^*}{ds}(s)' P(\gamma^*(s)) \frac{d}{ds} (f(\gamma^*(s))) \right] ds, \\ &= \int_{s_1}^{s_2} \left[ \frac{1}{2} \frac{\partial}{\partial x} \left( \frac{d\gamma^*}{ds}(s)' P(x) \frac{d\gamma^*}{ds}(s) \right) \Big|_{x=\gamma^*(s)} f(\gamma^*(s)) \right. \\ &\quad \left. + \frac{d\gamma^*}{ds}(s)' P(\gamma^*(s)) \frac{\partial f}{\partial x}(\gamma^*(s)) \frac{d\gamma^*}{ds}(s) \right] ds. \end{aligned}$$

<sup>4</sup>In [31, Theorem 6.14], the result is stated with  $\gamma^*$   $C^\infty$  note however that  $C^2$  is enough.

Here the integrand is nothing but the left hand side of (59). With a compactness argument<sup>5</sup> we can show that condition (59) in Proposition 7 is equivalent to the existence of a smooth function  $\nu : \mathbb{R}^n \rightarrow \mathbb{R}_+$  such that, for all  $(x, v)$ ,

$$\frac{1}{2} v' \mathfrak{d}_f P(x) v + v' P(x) \frac{\partial f}{\partial x}(x) v \leq -\lambda v' P(x) v + \nu(x) \left| \frac{\partial U}{\partial x}(x) v \right|^2 .$$

Hence, the geodesic being normalized, we have :

$$C(w) + \lambda \int_{s_1}^{s_2} \frac{d\gamma^*}{ds}(s)' P(\gamma^*(s)) \frac{d\gamma^*}{ds}(s) ds = C(w) + \lambda d(w_1, w_2) \leq B(w) ,$$

with the notation :

$$B(w) = \int_{s_1}^{s_2} \nu(\gamma^*(s)) \left| \frac{\partial U}{\partial x}(\gamma^*(s)) \frac{d\gamma^*}{ds}(s) \right|^2 ds .$$

From  $A$  and  $B$  we define two  $C^2$  functions  $a$  and  $b$  by dividing by  $d(w_1, w_2) = s_2 - s_1$ . Namely, we define :

$$a_{\gamma^*}(w, r) = \frac{U(\gamma^*(r + s_1)) - U(w_1)}{r} \times \left[ \frac{\partial U}{\partial x}(\gamma^*(r + s_1)) \frac{d\gamma^*}{ds}(\gamma^*(r + s_1)) + \frac{\partial U}{\partial x}(w_1) \frac{d\gamma^*}{ds}(s_1) \right] \quad (66)$$

$$b_{\gamma^*}(w, r) = \frac{1}{r} \int_{s_1}^{r+s_1} \nu(\gamma^*(s)) \left| \frac{\partial U}{\partial x}(\gamma^*(s)) \frac{d\gamma^*}{ds}(s) \right|^2 ds . \quad (67)$$

They are defined on  $\mathbb{R}^{2n} \setminus \mathcal{D} \times ]0, d(w_1, w_2)]$  and depend a priori on the particular minimizing geodesic  $\gamma^*$  we consider. We extend by continuity (in  $r$ ) their definition to  $\mathbb{R}^{2n} \setminus \mathcal{D} \times [0, d(w_1, w_2)]$  by letting

$$a_{\gamma^*}(w, 0) = 2 \left| \frac{\partial U}{\partial x}(\gamma^*(s_1)) \frac{d\gamma^*}{ds}(s_1) \right|^2 ,$$

$$b_{\gamma^*}(w, 0) = \nu(\gamma^*(s_1)) \left| \frac{\partial U}{\partial x}(\gamma^*(s_1)) \frac{d\gamma^*}{ds}(s_1) \right|^2 .$$

In this way, for any pair  $(w_1, w_2)$  in  $\mathbb{R}^{2n} \setminus \mathcal{D}$  and any minimizing geodesic  $\gamma^*$  between  $w_1$  and  $w_2$ , – the function  $r \mapsto (a_{\gamma^*}(w, r), b_{\gamma^*}(w, r))$  is defined and  $C^1$ <sup>6</sup> on  $[0, d(w_1, w_2)]$ ,

<sup>5</sup>The following two properties are equivalent

a)  $v' f(x) v < 0$  for all  $v$  with  $|v| = 1$  and all  $x$  satisfying  $g(x) v = 0$

b) there exists  $\nu$  such that  $v' f(x) v - \nu(x) |g(x) v|^2 \leq 0$  for all  $v$  with  $|v| = 1$  and all  $x$ .

*Proof* b)  $\Rightarrow$  a) is trivial. For the converse, let  $C$  be an arbitrary compact set, if b) does not hold for some  $\eta_C$  and all  $x$  in  $C$ , there exist  $x_i$  and  $v_i$  with  $|v_i| = 1$  satisfying  $v_i' f(x_i) v_i \geq \eta_C |g(x_i) v_i|^2$ . With compactness this implies the existence of  $x_\omega$  and  $v_\omega$  with  $|v_\omega| = 1$  satisfying  $g(x_\omega) v_\omega = 0$  and  $v_\omega' f(x_\omega) v_\omega \geq 0$ . This contradicts a).

<sup>6</sup> This comes from this general result. Let  $f$  be a  $C^2$  function defined on a neighborhood of 0 in  $\mathbb{R}$ , where it is 0. The function  $\varphi$  defined as  $\varphi(r) = \frac{f(r)}{r}$  if  $r \neq 0$  and  $\varphi(0) = f'(0)$  is  $C^1$ .

Indeed it is clearly  $C^2$  everywhere except may be at 0. Its first derivative is  $\varphi'(r) = \frac{f(r) - r f'(0)}{r^2}$ . It is also continuous

– we have :

$$\frac{1}{d(w_1, w_2)} \frac{d}{dt} \left( L(\Gamma(s, t)) \Big|_{s_1}^{s_2} \right) \Big|_{t=0} + \lambda \leq b_{\gamma^*}(w, d(w_1, w_2)) - \ell(w) a_{\gamma^*}(w, d(w_1, w_2)) .$$

Also

**Lemma 1.** For any pair  $(w_1, w_2)$  in  $\mathbb{R}^{2n} \setminus \mathcal{D}$  and any minimizing geodesic  $\gamma^*$  between  $w_1$  and  $w_2$ ,  $a_{\gamma^*}(w, d(w_1, w_2))$  is non negative, and if it is zero, the same holds for  $b_{\gamma^*}(w, d(w_1, w_2))$ .

*Proof :* For any pair  $w$  in  $\mathbb{R}^{2n} \setminus \mathcal{D}$ , the function  $r \rightarrow a_{\gamma^*}(w, r)$  is defined and continuous on  $[0, d(w_1, w_2)]$ .

If the real number

$$a_{\gamma^*}(w, 0) = 2 \left| \frac{\partial U}{\partial x}(\gamma^*(s_1)) \frac{d\gamma^*}{ds}(s_1) \right|^2$$

is zero, the level sets of  $U$  being totally geodesic, we have

$$\frac{\partial U}{\partial x}(\gamma^*(r + s_1)) \frac{d\gamma^*}{ds}(r + s_1) = 0, \quad \forall r \in [0, d(w_1, w_2)] .$$

$$U(\gamma^*(r + s_1)) = U(w_1) ,$$

and so  $U(w_2) = U(w_1)$  and  $a_{\gamma^*}(w, d(w_1, w_2))$  and  $b_{\gamma^*}(w, d(w_1, w_2))$  are zero.

If instead that real number is positive and

$$a_{\gamma^*}(w, d(w_1, w_2)) = \frac{U(\gamma^*(s_2)) - U(w_1)}{d(w_1, w_2)} \times \left[ \frac{\partial U}{\partial x}(\gamma^*(s_2)) \frac{d\gamma^*}{ds}(\gamma^*(s_2)) + \frac{\partial U}{\partial x}(w_1) \frac{d\gamma^*}{ds}(s_1) \right]$$

is non positive, then there exists  $r_0$  in  $]0, d(w_1, w_2)[$  such that

either  $U(\gamma^*(r_0 + s_1)) = U(w_1)$ . But the level sets of  $U$  being totally geodesic and  $\gamma^*$  being a minimizing geodesic between  $w_1$  and  $w_2$  and therefore between  $w_1$  and  $\gamma^*(r_0 + s_1)$ , it follows from

---

at 0 since  $\lim_{r \rightarrow 0} \varphi(r) = f'(0) = \varphi(0)$ . Its first derivative at 0 exists if  $\lim_{r \rightarrow 0} \frac{\varphi(r) - \varphi(0)}{r} = \lim_{r \rightarrow 0} \frac{f(r) - rf'(0)}{r^2}$  exists. But this is the case, since  $f$  being  $C^2$ , we have

$$\begin{aligned} \frac{f(r) - rf'(0)}{r^2} &= \frac{1}{r^2} \int_0^r [f'(s) - f'(0)] ds \\ &= \frac{1}{r^2} \int_0^r \int_0^s f''(t) dt ds \\ &= \frac{1}{r^2} \int_0^r f''(t) [r - t] dt \end{aligned}$$

which leads to  $\varphi'(0) = \frac{1}{2} f''(0)$ . We have also

$$\frac{f(r) - rf'(r)}{r^2} = -\frac{1}{r^2} \int_0^r s f''(s) ds$$

This implies

$$\lim_{r \rightarrow 0} \varphi'(r) = \varphi'(0)$$

and therefore  $\varphi'$  is continuous.

(the proof of) [27, Proposition A.3.2] that  $\gamma^*$  takes its values in the level set  $\{x : U(x) = U(w_1)\}$  at least on  $[s_1, r_0 + s_1]$ . This implies

$$\frac{\partial U}{\partial x}(\gamma^*(s)) \frac{d\gamma^*}{ds}(s) = 0$$

for all  $s$  in  $[s_1, r_0 + s_1]$  and consequently in  $[s_1, s_2]$ . This yields  $U(w_2) = U(w_1)$  and  $a_{\gamma^*}(w, d(w_1, w_2))$  and  $b_{\gamma^*}(w, d(w_1, w_2))$  are zero;

or we have

$$\begin{aligned} \frac{\partial U}{\partial x}(\gamma^*(r_0 + s_1)) \frac{d\gamma^*}{ds}(\gamma^*(r_0 + s_1)) + \frac{\partial U}{\partial x}(\gamma^*(s_1)) \frac{d\gamma^*}{ds}(s_1) \\ = 0 . \end{aligned}$$

This implies that  $\frac{\partial U}{\partial x}(\gamma^*(s_1)) \frac{d\gamma^*}{ds}(s_1)$  and  $\frac{\partial U}{\partial x}(\gamma^*(r_0 + s_1)) \frac{d\gamma^*}{ds}(r_0 + s_1)$  have opposite signs and so the function  $r \mapsto \frac{\partial U}{\partial x}(\gamma^*(r + s_1)) \frac{d\gamma^*}{ds}(r + s_1)$  must vanish on  $]0, r_0[$ . Again this implies  $U(w_2) = U(w_1)$  and  $a_{\gamma^*}(w, d(w_1, w_2))$  and  $b_{\gamma^*}(w, d(w_1, w_2))$  are zero.  $\square$

Now, to each pair of integers  $(i_1, i_2)$ , we associate the compact set

$$C_{i_1 i_2} = \left\{ (w_1, w_2) \in \mathbb{R}^{2n} : \right. \\ \left. i_1 \leq d(w_1, 0) \leq i_1 + 1, i_2 \leq d(w_2, 0) \leq i_2 + 1 \right\} .$$

**Lemma 2.** *For any pair  $(i_1, i_2)$ , there exists a real number  $\ell_{i_1 i_2}$  such that, for all  $(w_1, w_2)$  in  $C_{i_1 i_2} \setminus \mathcal{D}$  and all  $\ell$  larger or equal to  $\ell_{i_1 i_2}$ , we have :*

$$b(w, d(w_1, w_2)) - \ell a(w, d(w_1, w_2)) \leq \frac{\lambda}{2} . \quad (68)$$

*Proof :* For the sake of getting a contradiction, assume there exist a pair  $(i_1, i_2)$  and a sequence  $(w_{1k}, w_{2k}, \gamma_k^*)_{k \in \mathbb{N}}$  of points and minimizing geodesic satisfying

$$\begin{aligned} d(w_{1k}, w_{2k}) &\neq 0 \\ w_{1k} &= \gamma_k^*(0) \\ w_{2k} &= \gamma_k^*(d(w_{1k}, w_{2k})) \\ &= w_{1k} + \int_0^{d(w_{1k}, w_{2k})} \frac{d\gamma_k^*}{ds}(s) ds \end{aligned} \quad (69)$$

and

$$\begin{aligned} -\frac{\lambda}{2} + b_{\gamma_k^*}(w_{1k}, w_{2k}, d(w_{1k}, w_{2k})) \\ \geq k a_{\gamma_k^*}(w_{1k}, w_{2k}, d(w_{1k}, w_{2k})) \geq 0 . \end{aligned} \quad (70)$$

Because the sequence  $(b_{\gamma_k^*}(w_{1k}, w_{2k}, d(w_{1k}, w_{2k})))_{k \in \mathbb{N}}$  is bounded, we have

$$\lim_{k \rightarrow \infty} a_{\gamma_k^*}(w_{1k}, w_{2k}, d(w_{1k}, w_{2k})) = 0 . \quad (71)$$

The sequence  $(w_{1k}, w_{2k})_{k \in \mathbb{N}}$  has a cluster point  $(w_{1\omega}, w_{2\omega})$ . To keep the notations simple, we still denote by  $k$  the index of the subsequence for which we have convergence to this point.

Case 1 :  $w_{1\omega} = w_{2\omega} = w_\omega$ . Assume we have

$$\lim_{k \rightarrow \infty} d(w_{1k}, w_{2k}) = \lim_{k \rightarrow \infty} d(w_{1k}, w_\omega) = \lim_{k \rightarrow \infty} d(w_{2k}, w_\omega) = 0.$$

By compactness,  $C^1$  property and boundedness, there exists a real number  $M$  and an integer  $k_*$  such that, for all  $k$  larger than  $k_*$ , we have

$$\begin{aligned} a_{\gamma_k^*}(w_{1k}, w_{2k}, d(w_{1k}, w_{2k})) & \\ & \geq a_{\gamma_k^*}(w_{1k}, w_{2k}, 0) - M d(w_{1k}, w_{2k}) \\ & \geq 2 \left| \frac{\partial U}{\partial x}(w_{1k}) \frac{d\gamma_k^*}{ds}(0) \right|^2 - M d(w_{1k}, w_{2k}) \\ b_{\gamma_k^*}(w_{1k}, w_{2k}, d(w_{1k}, w_{2k})) & \\ & \leq b_{\gamma_k^*}(w_{1k}, w_{2k}, 0) + M d(w_{1k}, w_{2k}) \\ & \leq \nu(w_{1k}) \left| \frac{\partial U}{\partial x}(w_{1k}) \frac{d\gamma_k^*}{ds}(0) \right|^2 + M d(w_{1k}, w_{2k}) \end{aligned}$$

This implies

$$\begin{aligned} -\frac{\lambda}{2k} + \left[ \frac{\nu(w_{1k})}{k} - 2 \right] \left| \frac{\partial U}{\partial x}(w_{1k}) \frac{d\gamma_k^*}{ds}(0) \right|^2 \\ \geq -M \left[ \frac{1}{k} + 1 \right] d(w_{1k}, w_{2k}) \end{aligned}$$

and therefore

$$\lim_{k \rightarrow \infty} \left| \frac{\partial U}{\partial x}(w_{1k}) \frac{d\gamma_k^*}{ds}(0) \right|^2 = 0 \quad (72)$$

Also, by compactness  $\frac{w_{2k} - w_{1k}}{d(w_{1k}, w_{2k})}$  has a cluster point we denote  $v_\omega$ . With again  $k$  as index for the subsequence (of the subsequence!), we have

$$v_\omega = \lim_{k \rightarrow \infty} \frac{w_{2k} - w_{1k}}{d(w_{1k}, w_{2k})}$$

But with (69), this gives also

$$v_\omega = \lim_{k \rightarrow \infty} \frac{d\gamma_k^*}{ds}(0)$$

which, with (72), gives :

$$\frac{\partial U}{\partial x}(w_\omega) v_\omega = 0$$

and implies :

$$\lim_{k \rightarrow \infty} b_{\gamma_k^*}(w_{1k}, w_{2k}, d(w_{1k}, w_{2k})) = 0$$

Since  $a_{\gamma_k^*}(w_{1k}, w_{2k}, d(w_{1k}, w_{2k}))$  is non negative, this contradicts (70).

Case 2 :  $w_{1\omega} \neq w_{2\omega}$ . Assume now we have

$$\lim_{k \rightarrow \infty} d(w_{1k}, w_{1\omega}) = \lim_{k \rightarrow \infty} d(w_{2k}, w_{2\omega}) = 0 ,$$

$$d(w_{1\omega}, w_{2\omega}) \neq 0 .$$

$(w_{1k}, w_{2k})$  is in the compact set  $C_{i_1 i_2}$  and  $\gamma_k^*$  is a minimal geodesic at least on  $[0, d(w_{1k}, w_{2k})]$ . So, from :

$$\sqrt{\underline{p}} |w_1 - w_2| \leq d(w_1, w_2) \leq \sqrt{\underline{p}} |w_1 - w_2|$$

$$\forall (w_1, w_2) \in \mathcal{C} \times \mathcal{C} ,$$

we get, for all  $s$  in  $[0, d(w_{1k}, w_{2k})]$ ,

$$\sqrt{\underline{p}} |\gamma_k^*(s) - w_{1k}| \leq d(\gamma_k^*(s), w_{1k}) \leq d(w_{1k}, w_{2k}) \leq D_{i_1 i_2}$$

where

$$D_{i_1 i_2} = \sup_{(w_1, w_2) \in C_{i_1 i_2}} d(w_1, w_2)$$

We have also

$$\begin{aligned} |w_{1k}| &\leq |w_{2k} - w_{1k}| + |w_{2k}| \\ &\leq \frac{d(w_{2k}, w_{1k}) + d(w_{2k}, 0)}{\sqrt{\underline{p}}} , \\ &\leq \frac{D_{i_1 i_2} + (i_2 + 1)}{\sqrt{\underline{p}}} . \end{aligned}$$

With the completeness of the metric, this implies that  $\gamma_k^* : [0, D_{i_1 i_2}] \rightarrow \mathbb{R}^n$  takes its values in a compact set independent of the index  $k$  and is a solution of the geodesic equation. It follows, from instance from [10, Theorem 5, §1], that there exist a subsequence (of the subsequence !) again with  $k$  as index and a solution  $\gamma_\omega^*$  of the geodesic equation satisfying,

$$\gamma_\omega^*(0) = w_{1\omega} \quad , \quad \gamma_\omega^*(d(w_{1\omega}, w_{2\omega})) = w_{2\omega} .$$

and

$$\lim_{k \rightarrow \infty} \gamma_k^*(s) = \gamma_\omega^*(s) \quad \text{uniformly in } s \in [0, D_{i_1 i_2}] .$$

Also each  $\gamma_k^*$  being minimizing between  $w_{1k}$  and  $w_{2k}$ ,  $\gamma_\omega^*$  is minimizing between  $w_{1\omega}$  and  $w_{2\omega}$  (see [26, Lemma II—4.2]). With the definitions (66) and (67) of  $a_{\gamma^*}(w_1, w_2, d(w_1, w_2))$  and  $b_{\gamma^*}(w_1, w_2, d(w_1, w_2))$  and with (71) we obtain

$$\begin{aligned} a_{\gamma_\omega^*}(w_{1\omega}, w_{2\omega}, d(w_{1\omega}, w_{2\omega})) &= \lim_{k \rightarrow \infty} a_{\gamma_k^*}(w_{1k}, w_{2k}, d(w_{1k}, w_{2k})) , \\ &= 0 , \end{aligned}$$

$$\begin{aligned} b_{\gamma_\omega^*}(w_{1\omega}, w_{2\omega}, d(w_{1\omega}, w_{2\omega})) &= \lim_{k \rightarrow \infty} b_{\gamma_k^*}(w_{1k}, w_{2k}, d(w_{1k}, w_{2k})) . \end{aligned}$$

With Lemma 1, we get :

$$b_{\gamma_\omega^*}(w_{1\omega}, w_{2\omega}, d(w_{1\omega}, w_{2\omega})) = 0$$

So, as in the previous case, we get a contradiction of (70).

To complete the proof of Proposition 7, it is sufficient to observe that for any pair  $(w_1, w_2)$  in  $\mathbb{R}^{2n}$ , we can find  $(i_1, i_2)$  such that  $C_{i_1 i_2}$  contains it. It is then sufficient to pick  $\ell(w_1, w_2)$  larger or equal to  $\ell_{i_1 i_2}$  to obtain, with (68),

$$\mathfrak{D}^+ d(w_1, w_2) \leq \frac{d}{dt} \left( L(\Gamma(s, t)) \Big|_{s_1}^{s_2} \right) \Big|_{t=0} \leq -\frac{\lambda}{2} d(w_1, w_2)$$

This gives :

$$\begin{aligned} \sqrt{p} |W_1(w_1, w_2, t) - W_2(w_1, w_2, t)| & \\ & \leq d(W_1(w_1, w_2, t) - W_2(w_1, w_2, t)) , \\ & \leq \exp\left(-\frac{\lambda}{2}t\right) d(w_1, w_2) , \\ & \leq \exp\left(-\frac{\lambda}{2}t\right) \sqrt{p} |w_1 - w_2| . \end{aligned} \quad \square$$
