# Mixed Precision Low Rank Approximations and their Application to Block Low Rank LU Factorization $\dagger$

We introduce a novel approach to exploit mixed precision arithmetic for low-rank approximations. Our approach is based on the observation that singular vectors associated with small singular values can be stored in lower precisions while preserving high accuracy overall. We provide an explicit criterion to determine which level of precision is needed for each singular vector. We apply this approach to block low-rank (BLR) matrices, most of whose off-diagonal blocks have low rank. We propose a new BLR LU factorization algorithm that exploits the mixed precision representation of the blocks. We carry out the rounding error analysis of this algorithm and prove that the use of mixed precision arithmetic does not compromise the numerical stability of the BLR LU factorization. Moreover our analysis determines which level of precision is needed for each floating-point operation (flop), and therefore guides us towards an implementation that is both robust and efficient. We evaluate the potential of this new algorithm on a range of matrices coming from real-life problems in industrial and academic applications. We show that a large fraction of the entries in the LU factors and flops to perform the BLR LU factorization can be safely switched to lower precisions, leading to significant reductions of the storage and expected time costs, of up to a factor three using $\mathrm{fp} 64, \mathrm{fp} 32$, and bfloat 16 arithmetics.

## 1. Introduction

The emergence of low precision arithmetics on modern hardware, such as the half precision floatingpoint formats fp16 and bfloat 16 , has generated a renewed interest in mixed precision algorithms. These algorithms combine low precisions with higher ones in order to improve the performance of the computations (speed, memory and energy consumption) without compromising their accuracy or stability. New mixed precision variants of numerical linear algebra algorithms have been recently proposed, for example, for matrix multiplication (Blanchard et al., 2020b,a; Markidis et al., 2018; Mukunoki et al., 2020; Ahmad et al., 2019), iterative refinement (Carson \& Higham, 2017, 2018; Haidar et al., 2018; Amestoy et al., 2021), LU (Blanchard et al., 2020b; Lopez \& Mary, 2020) and QR (Yamazaki et al., 2015; Yang et al., 2021) matrix factorizations, Krylov solvers (Gratton et al., 2019; Agullo et al., 2020), least squares problems (Carson et al., 2020), and many others. See Higham \& Mary (2021) for a survey of these algorithms.

In this article, we investigate the use of mixed precision arithmetic in a new class of algorithms: low-rank approximations, in particular those obtained with a singular value decomposition or a rankrevealing decomposition (such as QR with column pivoting). Let $A \in \mathbb{R}^{m \times n}$ and let $X \Sigma Y^{T}=\sum_{i=1}^{\min (m, n)} x_{i} \sigma_{i} y_{i}^{T}$ be its singular value decomposition (SVD) ${ }^{1}$. Given a target accuracy $\varepsilon$, a low-rank approximation $T$ of A satisfying $\|T-A\| \leqslant \varepsilon\|A\|$ can be built from the truncated $\operatorname{SVD} T=\sum_{i=1}^{r} x_{i} \sigma_{i} y_{i}^{T}$, where $r$ is the rank of $T$.

Our starting idea for this work is to ask what precision should be used to store $T$ and to operate on it. In the literature, the truncated SVD (or indeed any other form of low-rank decomposition) is stored in the lowest possible precision with unit roundoff safely smaller than $\varepsilon$; for example, if $\varepsilon=10^{-12}$ and we have access to the floating-point arithmetics defined by the IEEE standard, existing algorithms would use double precision (for which the unit roundoff is $u_{d} \approx 1 \times 10^{-16}$ ), because the next lower precision, single precision, has a unit roundoff $u_{s} \approx 6 \times 10^{-8}$ much larger than the prescribed $\varepsilon$.

However, in this article we explain why and how we can actually exploit much lower precisions, with almost no loss of accuracy. We show that singular vectors associated with sufficiently small singular values can be stored at precisions with unit roundoff larger than $\varepsilon\|A\|$ while maintaining an overall approximation accuracy of order $\varepsilon\|A\|$. For example, with $\varepsilon=10^{-12}$, any singular vector $x_{i}$ whose associated singular value $\sigma_{i}$ is smaller than $\varepsilon\|A\| / u_{s} \approx 2 \times 10^{-5}\|A\|$ can be stored in single precision. Indeed, the single precision vector $\widehat{x}_{i}$ satisfies $\left\|\widehat{x}_{i}-x_{i}\right\| \leqslant u_{s}$, but the overall error introduced by replacing $x_{i}$ by $\widehat{x}_{i}$ is bounded by $\left\|\left(\widehat{x}_{i}-x_{i}\right) \sigma_{i} y_{i}^{T}\right\| \leqslant\left(\varepsilon\|A\| / u_{s}\right) u_{s}=\varepsilon\|A\|$. As can be seen from this example, the reason we can afford to convert some singular vectors to lower precision is because the error introduced by this conversion is demagnified by the singular value; hence the error may be safely bounded if $\sigma_{i}$ is small enough.

In the following we formalize this intuition with an error analysis considering an arbitrary number of precisions. Moreover our analysis applies to any low-rank decomposition of the form $T=X Y^{T}$ where $X$ has orthonormal columns. Indeed, the mixed-precision approach presented here is general and can be used for several other low-rank approximations, in particular rank-revealing QR decompositions.

Clearly, the potential of the proposed approach depends on whether the singular values of the matrices to be approximated decay rapidly. In the second part of this article, we apply this approach to an important class of matrices: data sparse, rank-structured matrices, whose off-diagonal blocks have low numerical rank (Bebendorf, 2008). We focus in particular on the block low-rank (BLR) format (Amestoy

[^0]et al., 2015, 2017), although the approach is also applicable to hierarchical formats. Our numerical experiments demonstrate that the proposed mixed precision low-rank representation presents a very high potential in this context: a large fraction of both the entries needed to represent BLR matrices and the floating-point operations (flops) needed to compute their LU factorization can be switched to lower precisions.

The rest of this article is organized as follows. In section 2, we describe the proposed mixed precision low-rank representation and show that the loss of accuracy introduced by the use of lower precisions can be rigorously bounded. We then apply this representation to BLR matrices in section 3. In section 4, we analyze how to compute the LU factorization of a BLR matrix using mixed precision arithmetic. We present numerical experiments on a range of real-life matrices in section 5, before concluding in section 6 .

Throughout the article, the unsubscripted norm $\|\cdot\|$ denotes the Frobenius norm

\|A\|=\left(\sum_{i=1}^{m} \sum_{j=1}^{n} a_{i j}^{2}\right)^{1 / 2}=\left(\sum_{i=1}^{\min (m, n)} \sigma_{i}^{2}\right)^{1 / 2} . \tag{1.1}
\end{equation*}

We also define $\gamma_{k}^{(\ell)}=k u_{\ell} /\left(1-k u_{\ell}\right)$ for any unit roundoff $u_{\ell}$ and for any $k$ such that $k u_{\ell}<1$. Given two matrices $A$ and $B$, we use the notation $|A| \leqslant|B|$ to denote the elementwise inequality $\left|a_{i j}\right| \leqslant\left|b_{i j}\right|$.

In our experiments, we will work with IEEE double and single precision arithmetics (denoted as fp64 and fp32, respectively) and bfloat16 arithmetic. The unit roundoffs for these three arithmetics are $u_{d}=2^{-53} \approx 1 \times 10^{-16}, u_{s}=2^{-24} \approx 6 \times 10^{-8}$, and $u_{h}=2^{-8} \approx 4 \times 10^{-3}$, respectively.

## 2. Mixed precision low-rank approximations

Let $A \in \mathbb{R}^{m \times n}$ and let $T$ be a low-rank approximation of $A$ satisfying

$$
\begin{equation*}
\|A-T\| \leqslant \varepsilon \beta \tag{2.1}
\end{equation*}
$$

where $\varepsilon>0$ is the target accuracy and where $\beta$ is a scaling parameter chosen by the user: a natural choice is $\beta=\|A\|$, which leads to an accuracy of $\varepsilon$ relative to $\|A\|$, but other choices are possible and will be explored in the next sections on BLR matrices.

Hereinafter, we refer to the precision that $T$ is stored in as the working precision, and we assume that its unit roundoff $u_{1}$ is safely smaller than $\varepsilon$, that is, $u_{1} \ll \varepsilon$.

Given the SVD $A=\sum_{i=1}^{n} x_{i} \sigma_{i} y_{i}^{T}$, it is well known that the approximation of $A$ of lowest rank is given by the truncated SVD

$$
\begin{equation*}
T=X \Sigma Y^{T}=\sum_{i=1}^{r} x_{i} \sigma_{i} y_{i}^{T}, \quad X \in \mathbb{R}^{m \times r}, Y \in \mathbb{R}^{n \times r} \tag{2.2}
\end{equation*}
$$

where the rank $r$ is the smallest integer such that (2.1) is satisfied. Neglecting any noise associated with the working precision, $r$ is given by

$$
\begin{equation*}
r=\min \left\{k:\left(\sum_{i=k+1}^{\min (m, n)} \sigma_{i}^{2}\right)^{1 / 2} \leqslant \varepsilon \beta\right\} . \tag{2.3}
\end{equation*}
$$

The goal of this section is to prove that depending on the singular values of $T$, we can use lower precisions than the working precision (with unit roundoff larger than $\varepsilon$ ) and still preserve an overall approximation error of order $\varepsilon$. We first carry out our analysis for the SVD, but also provide at the end
of this section its extension to other types of low-rank approximation methods, such as rank-revealing QR.

Our analysis assumes that the use of lower precision arithmetics with fewer exponent bits than the working precision does not lead to any overflow or underflow. To ensure that this assumption is satisfied in our experiments, we focus on the use of bfloat16 arithmetic (which has the same range as fp 32 ), rather than fp16 (which has a much narrower range).

Let us assume that $p$ different floating-point arithmetics are available (including the working precision $u_{1}$ ), and that their unit roundoffs satisfy

\end{equation*}

Let us consider a partition of matrix $T$ into $p$ groups

$$
T=X \Sigma Y^{T}=\left[X_{1} \ldots X_{p}\right]\left[\begin{array}{ccc}
\Sigma_{1} & &  \tag{2.5}\\
& \ddots & \\
& & \Sigma_{p}
\end{array}\right]\left[Y_{1} \ldots Y_{p}\right]^{T}
$$

where

$$
\begin{equation*}
T_{k}=X_{k} \Sigma_{k} Y_{k}^{T}, \quad X_{k} \in \mathbb{R}^{m \times r_{k}}, \Sigma_{k} \in \mathbb{R}^{r_{k} \times r_{k}}, Y_{k} \in \mathbb{R}^{n \times r_{k}} \tag{2.6}
\end{equation*}
$$

is a matrix of rank $r_{k}$ formed by the subset of the singular values and vectors of $T$ assigned to group $k$.
We now analyze the effect of converting $T_{k}$ to precision $u_{k}$. We assume that only the singular vectors $X_{k}$ and $Y_{k}$ are converted, whereas the singular values $\Sigma_{k}$ are kept in precision $u_{1}$. This is because the storage for $\Sigma_{k}$ is negligible compared with that of $X_{k}$ and $Y_{k}$. We however note that adapting the analysis to the case where $\Sigma_{k}$ is also converted to precision $u_{k}$ is straightforward and only slightly increases the constants in the error bounds. We write $\widehat{X}_{k}$ and $\widehat{Y}_{k}$ the converted vectors, and $\widehat{T}_{k}=\widehat{X}_{k} \Sigma_{k} \widehat{Y}_{k}^{T}$ (note that since $T_{1}$ is already in precision $u_{1}, \widehat{T}_{1}=T_{1}$ ). The following lemma bounds $\left\|\widehat{T}_{k}-T_{k}\right\|$ for $k \geqslant 2$. Since $X_{k}$ and $Y_{k}$ are stored in precision $u_{1}$, they only have approximately orthonormal columns. In the following lemma and throughout the article, we neglect this loss of orthonormality, which would only introduce a lower order term $O\left(\varepsilon u_{1}\right)$ in the error bounds.
LEMMA 2.1 Let $T_{k}=X_{k} \Sigma_{k} Y_{k}^{T}$ where $X_{k}$ and $Y_{k}$ have approximatively orthonormal columns (stored in precision $u_{1}$ ), and let $\widehat{T}_{k}=\widehat{X}_{k} \Sigma_{k} \widehat{Y}_{k}^{T}$ be obtained by converting $X_{k}$ and $Y_{k}$ to precision $u_{k}$. Then

$$
\begin{equation*}
\left\|\widehat{T_{k}}-T_{k}\right\| \leqslant\left(2+\sqrt{r_{k}} u_{k}\right) u_{k}\left\|\Sigma_{k}\right\| \tag{2.7}
\end{equation*}
$$

Proof. The converted $\widehat{X}_{k}$ and $\widehat{Y}_{k}$ satisfy, for $k \geqslant 2$,

$$
\begin{array}{ll}
\widehat{X}_{k}=X_{k}+E_{k}, & \left|E_{k}\right| \leqslant u_{k}\left|X_{k}\right|, \\
\widehat{Y}_{k}=Y_{k}+F_{k}, & \left|F_{k}\right| \leqslant u_{k}\left|Y_{k}\right| \tag{2.9}
\end{array}
$$

Therefore we have

$$
\begin{equation*}
\left\|T_{k}-\widehat{T}_{k}\right\| \leqslant\left\|E_{k} \Sigma_{k} Y_{k}^{T}\right\|+\left\|X_{k} \Sigma_{k} F_{k}^{T}\right\|+\left\|E_{k} \Sigma_{k} F_{k}^{T}\right\| . \tag{2.10}
\end{equation*}
$$

For the first term, we observe that

$$
\begin{align*}
\left\|E_{k} \Sigma_{k} Y_{k}^{T}\right\|^{2} & =\left\|E_{k} \Sigma_{k}\right\|^{2}  \tag{2.11}\\
& =\sum_{j} \sigma_{j}^{2} \sum_{i} e_{i j}^{2}  \tag{2.12}\\
& \leqslant \sum_{j} \sigma_{j}^{2} \sum_{i} u_{k}^{2} x_{i j}^{2}  \tag{2.13}\\
& =u_{k}^{2} \sum_{j} \sigma_{j}^{2}=u_{k}^{2}\left\|\Sigma_{k}\right\|^{2} \tag{2.14}
\end{align*}
$$

where we have used the fact that the columns of $X_{k}$ have a norm of 1 . Therefore

$$
\begin{equation*}
\left\|E_{k} \Sigma_{k} Y_{k}^{T}\right\| \leqslant u_{k}\left\|\Sigma_{k}\right\| \tag{2.15}
\end{equation*}
$$

Similarly, we also have

$$
\begin{equation*}
\left\|X_{k} \Sigma_{k} F_{k}^{T}\right\| \leqslant u_{k}\left\|\Sigma_{k}\right\| \tag{2.16}
\end{equation*}
$$

Finally, for the third term, we have $\left\|E_{k} \Sigma_{k} F_{k}^{T}\right\| \leqslant\left\|E_{k} \Sigma_{k}\right\|\left\|F_{k}\right\|$ and so

$$
\begin{equation*}
\left\|E_{k} \Sigma_{k} F_{k}^{T}\right\| \leqslant \sqrt{r_{k}} u_{k}^{2}\left\|\Sigma_{k}\right\| . \tag{2.17}
\end{equation*}
$$

Reinjecting (2.15), (2.16), and (2.17) into (2.10) yields the result.
Lemma 2.1 shows that converting $T_{k}$ to precision $u_{k}$ introduces an error of order $u_{k}\left\|\Sigma_{k}\right\|$, which is thus proportional to the size of the singular values in $\Sigma_{k}$. This fundamental observation is at the foundation of the mixed precision representation that we propose in this article. Indeed, Lemma 2.1 suggests that we can preserve an overall accuracy of order $\varepsilon \beta$ by partitioning the singular values in such a way that $\left\|\Sigma_{k}\right\| \approx \varepsilon \beta / u_{k}$.

In order to build such a partitioning where the size of the groups stored in lower precision is as large as possible, it is easy to see that we should start by including the smallest singular values in the last group first, until its norm exceeds $\varepsilon \beta / u_{p}$; at this point, we can start building group $p-1$ with the remaining singular values, and so on. Therefore, the $\Sigma_{k}$ are formed of consecutive singular values:

\begin{equation*}
\Sigma_{k}=\operatorname{diag}\left(\sigma_{i}\right), \quad i=i_{k}: i_{k+1}-1 \tag{2.18}
\end{equation*}
$$

where the indices $i_{k}$ and $i_{k+1}$ define which singular values are part of $\Sigma_{k}$, and can be computed by the recursive formula:

$$
\begin{equation*}
i_{k}=\min \left\{i:\left(\sum_{j=i}^{i_{k+1}-1} \sigma_{j}^{2}\right)^{1 / 2} \leqslant \varepsilon \beta / u_{k}\right\}, \quad k \in[2: p], \tag{2.19}
\end{equation*}
$$

starting with $i_{p+1}=r+1$ and ending with $i_{1}=1$. We thus end up with a partitioning of the SVD as defined by (2.18)-(2.19). Note that this definition may lead to some empty $\Sigma_{k}$, in which case $T_{k}$ is a rank-0 matrix. We note that this partitioning is similar to the Method 3 proposed by Ooi et al. (2020). Our analysis justifies the use of this partitioning and gives a precise rule to define the $p$ groups depending on the singular values and on the precisions.

This partitioning guarantees that $\left\|\Sigma_{k}\right\| \leqslant \varepsilon \beta / u_{k}$ for all $k \geqslant 2$ and so, by Lemma 2.1, converting $T_{k}$ to precision $u_{k}$ introduces an error bounded by

$$
\begin{equation*}
\left\|T_{k}-\widehat{T}_{k}\right\| \leqslant\left(2+\sqrt{r_{k}} u_{k}\right) \varepsilon \beta \tag{2.20}
\end{equation*}
$$

By combining (2.20) over $k=2: p$, we readily obtain a bound on the overall error introduced by converting each $T_{k}$ to precision $u_{k}$.

THEOREM 2.1 Let $T$ be a low-rank approximation of $A$ satisfying $\|A-T\| \leqslant \varepsilon \beta$. If $T$ is partitioned into $p$ groups $T_{k}=X_{k} \Sigma_{k} Y_{k}^{T}$ as defined by (2.18)-(2.19), and the $X_{k}$ and $Y_{k}$ are converted to precision $u_{k}$, the resulting matrix $\widehat{T}=\sum_{k=1}^{p} \widehat{T}_{k}=\sum_{k=1}^{p} \widehat{X}_{k} \Sigma_{k} \widehat{Y}_{k}$ satisfies

$$
\begin{equation*}
\|A-\widehat{T}\| \leqslant\left(2 p-1+\sum_{k=2}^{p} \sqrt{r_{k}} u_{k}\right) \varepsilon \beta \tag{2.21}
\end{equation*}
$$

Proof. The triangle inequality $\|A-\widehat{T}\| \leqslant\|A-T\|+\sum_{k=2}^{p}\left\|T_{k}-\widehat{T}_{k}\right\|$ together with (2.20) readily yields the result.

Theorem 2.1 shows that the mixed precision low-rank matrix $\widehat{T}$ approximates $A$ with an accuracy of order $\varepsilon$. To first order, the constant in this error bound is $2 p-1$, instead of 1 for the uniform precision matrix $T$ : the introduction of lower precisions therefore only increases the overall error by a very modest quantity. Moreover, we note that by means of a more sophisticated proof that avoids the use of the triangle inequality, this constant can be reduced to $2 \sqrt{p-1}$. However, we will not use such proofs for the sake of readability, and because the precise value of the constants in the error bounds is unimportant, as long as they are not too large.

Note that while Theorem 2.1 guarantees an approximation error $\|A-\widehat{T}\|$ in $O(\varepsilon)$, the errors on the low-rank factors $\|X-\widehat{X}\|$ and $\|Y-\widehat{Y}\|$ are in $O\left(u_{p}\right)$, the lowest precision used. Moreover, the loss of orthogonality of $X$ and $Y$ is also in $O\left(u_{p}\right)$. Therefore, one should be careful before using the proposed method in applications that make use of the singular vectors or their orthogonality.

Importantly, the proposed method can be applied to other types of low-rank decompositions, not necessarily based on SVD. For example, Theorem 2.1 can be easily extended to decompositions of the form $X B Y^{T}$, where $X$ and $Y$ have orthonormal columns (the difference with the SVD being that $B$ is not diagonal), bound (2.21) holds with a slightly larger constant; one example of this form is the UTV decomposition (Fierro \& Hansen, 1997). Our analysis can also be adapted to decompositions of the form $X Y^{T}$, where $X$ has orthonormal columns (but $Y$ does not). This second form is particularly of interest because it applies to rank-revealing QR decompositions. We state the analogue to Lemma 2.1 for $X Y^{T}$ decompositions below.

LEMMA 2.2 Let $T_{k}=X_{k} Y_{k}^{T}$ where $X_{k}$ has approximatively orthonormal columns (stored in precision $u_{1}$ ), and let $\widehat{T}_{k}=\widehat{X}_{k} \widehat{Y}_{k}$ be obtained by converting $X_{k}$ and $Y_{k}$ to precision $u_{k}$. Then

$$
\begin{equation*}
\left\|T_{k}-\widehat{T}_{k}\right\| \leqslant\left(2+\sqrt{r_{k}} u_{k}\right) u_{k}\left\|Y_{k}\right\| . \tag{2.22}
\end{equation*}
$$

Thus, the error introduced by converting group $k$ now depends on $\left\|Y_{k}\right\|$, and this means that the $X \Sigma Y^{T}$ partitioning (2.18)-(2.19) should be adapted by replacing $\left\|\Sigma_{k}\right\|$ by $\left\|Y_{k}\right\|$. Then, it is easy to show that Theorem 2.1 still holds. Lastly, the proposed method can even be applied to decompositions $X Y^{T}$ where neither $X$ nor $Y$ have orthonormal columns. In this case the error introduced by the conversion of $T_{k}$ to precision $u_{k}$ is

$$
\begin{equation*}
\left\|T_{k}-\widehat{T}_{k}\right\| \leqslant\left(2+u_{k}\right) u_{k}\left\|X_{k}\right\|\left\|Y_{k}\right\|, \tag{2.23}
\end{equation*}
$$

which shows that there is potential for mixed precision as long as the low-rank components $x_{i} y_{i}^{T}$ are of decreasing norm.

In the rest of this article, we will focus on low-rank decompositions of the form $X Y^{T}$, computed by means of a truncated QR factorization with column pivoting.

An important question is under what condition the low-rank compression is beneficial, that is, when does the low-rank approximation $T$ require less storage than the original matrix $A \in \mathbb{R}^{m \times n}$. In the
standard uniform precision case, $T=X Y^{T}$ can be represented with $r(m+n)$ entries, and so the condition is

$$
\begin{equation*}
r(m+n) \leqslant m n \tag{2.24}
\end{equation*}
$$

With a mixed precision representation, this condition changes due to the fact that entries belonging to groups $k \geqslant 2$ are stored in lower precision. The condition becomes

$$
\begin{equation*}
(m+n) \sum_{k=1}^{p} c_{k} r_{k} \leqslant m n \tag{2.25}
\end{equation*}
$$

where $c_{k}$ ponderates the cost of storing a floating-point number in precision $u_{k}$ instead of $u_{1}$. For example, if we use three precisions, fp64, fp32, and bfloat16, (2.25) takes the form $(m+n)\left(r_{1}+0.5 r_{2}+\right.$ $\left.0.25 r_{3}\right) \leqslant m n$. Interestingly, the difference between conditions (2.24) and (2.25) means that a matrix that is not "low-rank enough" in uniform precision can become so when using mixed precision arithmetic.

Crucially, the size $r_{k}$ of each group depends on the singular values. Indeed, group $k$ must satisfy $\left\|\Sigma_{k}\right\| \leqslant \varepsilon \beta / u_{k}$, so if the singular values of $A$ decay slowly, most of them must be kept in the first group and little gain can be expected from the use of mixed precision. Conversely, if $A$ possesses many small singular values, the low precision groups will be very large and the use of mixed precision will be very beneficial. Therefore, the potential gains achieved by the proposed approach completely depend on the singular values of the matrix. In the rest of this article, we focus on an important class of matrices that exhibit off-diagonal blocks with rapidly decaying singular values, and therefore present a high potential for the use of mixed precision.

## 3. Mixed precision BLR compression

Data sparse matrices are rank-structured matrices most of whose off-diagonal blocks have low numerical rank. In this section, we show how this property can be exploited to represent these matrices in mixed precision. We focus on a specific class of data sparse matrices, called the block low-rank (BLR) format (Amestoy et al., 2015, 2017, 2019b). The approach described here could also be extended to other formats, such as hierarchical (Hackbusch, 2015) or multilevel (Amestoy et al., 2019a) ones.

### 3.1 Background on BLR matrices

A block low-rank (BLR) representation $T$ of a dense square matrix $A \in \mathbb{R}^{n \times n}$ has the block $q \times q$ form

$$
T=\left[\begin{array}{cccc}
T_{11} & T_{12} & \cdots & T_{1 q}  \tag{3.1}\\
T_{21} & \cdots & \cdots & \vdots \\
\vdots & \cdots & \cdots & \vdots \\
T_{q 1} & \cdots & \cdots & T_{q q}
\end{array}\right]
$$

where $T_{i i}=A_{i i}$ (the diagonal blocks are not compressed), and where the off-diagonal blocks $A_{i j}$ of size $b \times b$ are approximated by matrices $T_{i j}$ satisfying

$$
\begin{equation*}
\left\|A_{i j}-T_{i j}\right\| \leqslant \varepsilon \beta_{i j} \tag{3.2}
\end{equation*}
$$

where $\beta_{i j}>0$. The $T_{i j}$ matrices, of rank $r_{i j}$, are given by

$$
T_{i j}= \begin{cases}X_{i j} Y_{i j}^{T}, & i>j  \tag{3.3}\\ Y_{i j} X_{i j}^{T}, & i<j\end{cases}
$$

where $X_{i j}$ and $Y_{i j}$ are $b \times r_{i j}$ matrices, and where $X_{i j}$ has orthornormal columns. Even though, in general, each block can be of different dimensions, we assume for simplicity that they are all of the same dimensions $b \times b$, and so $n=q b$. Representation (3.3) guarantees the so-called outer orthonormality property (Higham \& Mary, 2020; Mary, 2017), which allows for efficient intermediate recompressions during the factorization of a BLR matrix.

Importantly, the $\beta_{i j}$ parameters in (3.2) are used to distinguish two types of BLR compression, local and global, depending on whether block $T_{i j}$ approximates $A_{i j}$ with error $\varepsilon$ relative to the local norm $\beta_{i j}=\left\|A_{i j}\right\|$ or relative to the global norm $\beta_{i j}=\|A\|$. In their error analysis of the BLR factorization, Higham \& Mary (2020) show that global compression achieves a better tradeoff between compression and accuracy, and is therefore to be preferred. Throughout this article, we will thus use global compression, for which we have the global error bound

$$
\begin{equation*}
\|A-T\| \leqslant q \varepsilon\|A\| . \tag{3.4}
\end{equation*}
$$

Matrices amenable to BLR compression arise in a variety of applications, such as partial differential equations, integral equations, and covariance matrices. In this article, we focus on a range of dense matrices that are Schur complements of sparse matrices. Our test matrices are listed in Table 1, and we will illustrate some aspects of our analysis with the matrix P64. Figure 1 plots a heatmap of the numerical ranks of the blocks of this matrix.

### 3.2 Error analysis of mixed precision BLR compression

We now seek to combine BLR compression with the mixed precision representation proposed in section 2. The natural approach is to simply use this mixed precision representation on every low-rank off-diagonal block of the BLR matrix, leaving the full-rank blocks in the working precision $u_{1}$. Then, it is easy to show that (2.21) becomes

$$
\begin{equation*}
\left\|A_{i j}-\widehat{T}_{i j}\right\| \leqslant\left(2 p-1+\sum_{k=2}^{p} \sqrt{r_{i j}^{(k)}} u_{k}\right) \varepsilon \beta_{i j} \tag{3.5}
\end{equation*}
$$

where $r_{i j}^{(k)}$ is the rank of the matrix $\widehat{T}_{i j}^{(k)}=\widehat{X}_{i j}^{(k)}\left(\widehat{Y}_{i j}^{(k)}\right)^{T}$, that is, the number of columns of $X_{i j}$ and $Y_{i j}$ stored in precision $u_{k}$. The next result bounds the error introduced by mixed precision BLR compression.

THEOREM 3.1 (mixed precision BLR compression) Let $T$ be a BLR approximation of $A$ defined by (3.1)-(3.2) with $\beta_{i j}=\|A\|$ (global compression). If the off-diagonal blocks $T_{i j}$ are represented with the mixed precision representation $\widehat{T}_{i j}$ described in section 2, the resulting BLR matrix $\widehat{T}$ satisfies

$$
\begin{equation*}
\|A-\widehat{T}\| \leqslant q\left(2 p-1+\sum_{k=2}^{p} c_{k} u_{k}\right) \varepsilon\|A\| \tag{3.6}
\end{equation*}
$$

with $c_{k}=\max _{i, j} \sqrt{r_{i j}^{(k)}}$.
Proof. Using

$$
\begin{equation*}
\|A-\widehat{T}\|^{2}=\sum_{i=1}^{q} \sum_{j=1}^{q}\left\|A_{i j}-\widehat{T}_{i j}\right\|^{2} \tag{3.7}
\end{equation*}
$$

and (3.5), we readily obtain the result.
Compared with the uniform precision bound (3.4), the mixed precision bound (3.6) is thus larger by a modest factor of about $2 p-1$. Theorem 3.1 therefore shows that we can exploit mixed precision arithmetic in the BLR compression while preserving an accuracy of order $\varepsilon$.

### 3.3 Types of mixed precision blocks

Figure 2 shows an example of a mixed precision BLR matrix, plotting for each of its blocks the precisions that are effectively used to represent it. With $\varepsilon=10^{-10}$ and with three available precisions (fp64, fp32, and bfloat16), we can distinguish four types of blocks. The singular values of a representative example of each type are plotted in Figure 3.

First, the full-rank blocks (type 1, dark blue blocks in Figure 2, consisting of only the diagonal blocks here) are stored in the working precision (fp64). An example of diagonal block is given in Figure 3a, showing that its singular values decay too slowly to benefit from the use of a mixed precision

representation. However, there is only a small number of such blocks: the majority of the blocks therefore benefits from the use of lower precisions.

Interestingly, the number of low-rank blocks that effectively use all three precisions is quite small (type 2, light blue blocks, example given by Figure 3b). Most blocks actually do not need to store any of their entries in fp64. This is a consequence of using global compression: if $\beta_{i j}=\|A\| \gg\left\|A_{i j}\right\|$, fp64 is not needed to represent $A_{i j}$. In other words, blocks of sufficiently small norm can be stored entirely in lower precision. Among these blocks, we can further distinguish two types: those that are represented in mixed precision using both fp32 and bfloat 16 (type 3, green blocks, example given by Figure 3c) and those that are stored entirely in bfloat 16 (type 4 , yellow blocks, example given by Figure 3d). The type- 4 blocks are those whose norm is smaller than $\varepsilon\|A\| / u_{h}$, where $u_{h}=2^{-8}$ is the unit roundoff of bfloat 16 . Note that a fifth type of block could arise, those whose norm is smaller than $\varepsilon\|A\|$ : these blocks can simply be dropped, that is, replaced by zero (but no such blocks appear in the example of Figure 2).

The observation that blocks of small norm can be stored entirely in lower precision is important. It justifies why the simpler approach proposed by Abdulah et al. (2019) and Doucet et al. (2019) can already achieve significant gains. Their approach consists in storing each block in uniform precision, but possibly differing from one block to another. For example, for the matrix in Figure 2, all type-2 blocks (light blue) would need to be stored entirely in double precision, but type-3 blocks (green) could be stored entirely in single precision. Moreover, our error analysis provides the criterion that should be used to choose each block's precision: blocks $A_{i j}$ such that $\left\|A_{i j}\right\| \leqslant \varepsilon\|A\| / u_{i}$ can be stored in precision $u_{i}$.

## 4. Mixed precision BLR LU factorization

We now present how to exploit the mixed precision BLR representation described previously in order to accelerate the LU factorization of BLR matrices. There exists several BLR LU factorization algorithms, and here we focus on the so-called UCF (a.k.a. UCFS or FCSU) variant described in Algorithm 1. This variant has been successfully used in the literature, for example in the MUMPS (Amestoy et al., 2019b) and PaStiX (Pichon et al., 2018) sparse direct solvers, and its rounding error analysis in the uniform precision case has been carried out by Higham \& Mary (2020, sect. 4.2). We note that BLR LU factorization can and usually does incorporate numerical pivoting for stability, but we describe Algorithm 1 without pivoting for simplicity. Note that in the UCF variant, the matrix is not compressed from the beginning: instead, we perform the compression on the fly during the LU factorization (step 11 of Algorithm 1). To compress the $R_{i k}$ matrices, we use the same truncation criterion as in (3.2)

$$
\begin{equation*}
\left\|R_{i k}-T_{i k}\right\| \leqslant \varepsilon \beta_{i k}, \tag{4.1}
\end{equation*}
$$

where $\beta_{i k}>0$ is a parameter whose role has been discussed in the previous section (in practice we will use global compression by setting $\left.\beta_{i k}=\|A\|\right)$.

The error analysis presented in this section has a double purpose. First, it proves that the numerical stability of the uniform precision BLR LU factorization (proven by Higham \& Mary (2020)) is preserved in mixed precision arithmetic. Second, for each operation required by Algorithm 1, it determines which level of precision is needed to maintain the overall error of order $\varepsilon$. Our analysis therefore guides us towards an implementation of mixed precision BLR LU that is both robust and efficient.

One technical difficulty of this analysis is the handling of the scaling factors hidden inside the $U$ factor. To make these details more apparent, we analyze instead the LDU factorization, where $L$ and $U$ are unitriangular matrices (with ones on the diagonal). For the sake of readability, we will not always

keep track of lower order error terms; we use the notations $\approx$ and $\lesssim$ to indicate when these terms (of order at most $\left.u_{p} \varepsilon\right)$ have been dropped.

We first analyze each kernel separately. Algorithm 1 requires computing products of the form $L_{i j} D_{j j} U_{j k}$ (on line 7), where $L_{i j}$ and $U_{j k}$ may be either uniform precision full-rank blocks or mixed precision low-rank blocks (analysis of sections 4.1 and 4.2). We also analyze in section 4.3 the solution of a triangular system $L_{k k} D_{k k} U_{k i}=T_{k i}$ (needed on line 16), where the right-hand side $T_{k i}$ is a mixed precision low-rank matrix. Finally, we combine the analysis of these kernels to obtain a backward error bound on the mixed precision BLR LU factorization in section 4.4.

### 4.1 Low-rank matrix times full-rank matrix

Let us begin with the computation of a product $P=B C$, where $C$ is a full-rank matrix and $B=X Y^{T}$ is a mixed precision low-rank matrix partitioned into $p$ groups $B_{\ell}=X_{\ell} Y_{\ell}^{T}$ satisfying $\left\|B_{\ell}\right\| \leqslant \varepsilon \beta / u_{\ell}$ for $\ell>1$, and where the output $P$ is needed under full-rank form.

In which precision should we compute $P=B C$ ? The natural approach is to compute each product $P_{\ell}=B_{\ell} C$ in precision $u_{\ell}$. Then, using Higham \& Mary (2020, Lemma 3.2), the computed $\widehat{P}_{\ell}$ satisfies

$$
\begin{equation*}
\widehat{P}_{\ell}=B_{\ell} C+\Delta P_{\ell}, \quad\left\|\Delta P_{\ell}\right\| \leqslant \gamma_{c_{\ell}}^{(\ell)}\left\|B_{\ell}\right\|\|C\| \tag{4.2}
\end{equation*}
$$

with $c_{\ell}=b+r_{\ell}^{3 / 2}$. For $\ell>1$, we thus obtain

$$
\begin{equation*}
\widehat{P}_{\ell}=B_{\ell} C+\Delta P_{\ell}, \quad\left\|\Delta P_{\ell}\right\| \lesssim c_{\ell} \varepsilon \beta\|C\|, \tag{4.3}
\end{equation*}
$$

since $\gamma_{C_{\ell}}^{(\ell)} / u_{\ell}=c_{\ell}\left(1+\gamma_{c_{\ell}}^{(\ell)}\right) \approx c_{\ell}$. This shows that the partial product $P_{\ell}$ associated with the part of $B$ stored in precision $u_{\ell}$ can itself be computed in precision $u_{\ell}$, since the introduced error remains of order $\varepsilon$.

The next question is what precision should be used to combine the partial results into $P=\sum_{\ell=1}^{p} P_{\ell}$. Since for $\ell>1\left\|P_{\ell}\right\| \leqslant \varepsilon / u_{\ell} \beta\|C\|$, it is easy to see that $P_{i}+P_{j}$ must be computed in precision $\min \left(u_{i}, u_{j}\right)=$ $u_{\min (i, j)}$. Knowing this, in order to maximize the performance gains associated with the use of lower precisions, the best approach is to compute $\sum_{\ell=1}^{p} \widehat{P}_{\ell}$ in reverse order. The approach to compute $P$ suggested by our analysis is summarized in Algorithm 2.

With this algorithm, each component of $\widehat{P}_{\ell}$ is involved in exactly $\min (\ell, p-1)$ additions, one in each precision $u_{1}, \ldots, u_{\min (\ell, p-1)}$. Therefore the computed $\widehat{P}$ satisfies:

$$
\begin{equation*}
\widehat{P}=\sum_{\ell=1}^{p} \widehat{P}_{\ell} \circ\left(J+\Theta_{\ell}\right), \quad\left|\Theta_{\ell}\right| \lesssim u_{\ell} \tag{4.4}
\end{equation*}
$$

where $J$ is the matrix of ones, ○ denotes the Hadamard product, and the inequality $\left|\Theta_{\ell}\right| \lesssim u_{\ell}$ holds componentwise. Overall, we obtain

$$
\begin{align*}
\widehat{P} & =\sum_{\ell=1}^{p}\left(B_{\ell} C+\Delta P_{\ell}\right) \circ\left(J+\Theta_{\ell}\right)  \tag{4.5}\\
& =B C+\sum_{\ell=1}^{p} B_{\ell} C \circ \Theta_{\ell}+\Delta P_{\ell}+\Delta P_{\ell} \circ \Theta_{\ell}  \tag{4.6}\\
& =B C+\Delta P, \quad\|\Delta P\| \lesssim\left(\left(c_{1}+1\right) u_{1}\left\|B^{(1)}\right\|+\sum_{\ell=2}^{p}\left(c_{\ell}+1\right) \varepsilon \beta\right)\|C\|  \tag{4.7}\\
& =B C+\Delta P, \quad\|\Delta P\| \lesssim\left(p b+r^{3 / 2}+p\right) \max \left(u_{1}\left\|B^{(1)}\right\|, \varepsilon \beta\right)\|C\| \tag{4.8}
\end{align*}
$$

We summarize this analysis in the next theorem.
THEOREM 4.1 Let $B=\sum_{\ell=1}^{p} B_{\ell} \in \mathbb{R}^{b \times b}$ be a mixed precision low-rank matrix of rank $r$ such that $\left\|B_{\ell}\right\| \leqslant \varepsilon \beta / u_{\ell}$ for $\ell>1$, and let $C \in \mathbb{R}^{b \times b}$. If $P=B C$ is computed as described by Algorithm 2, then the computed $\widehat{P}$ satisfies

$$
\begin{equation*}
\|\widehat{P}-B C\| \lesssim c \max \left(u_{1}\|B\|, \varepsilon \beta\right)\|C\| \tag{4.9}
\end{equation*}
$$

with $c=p b+r^{3 / 2}+p$.
Theorem 4.1 shows that we can perform many of the flops in Algorithm 2 in lower precisions and still maintain an error of order $\varepsilon$. We now prove similar results for the other kernels.

### 4.2 Low-rank matrix times low-rank matrix

Next we analyze the product $P=B D C$ of two mixed precision low-rank matrices $B=X_{B} Y_{B}^{T}$ and $C=Y_{C} X_{C}^{T}$, where we also incorporate a diagonal scaling matrix $D$, which will be useful for the LU factorization analysis of section 4.4.

The product $P$, which is needed in full-rank form, can be computed in the following three steps:

1. Compute the inner product $M=\left(Y_{B}\right)^{T} D Y_{C}$.
2. Compute the middle product $W=X_{B} M$ (or $W=M X_{C}^{T}$ ).
3. Compute the outer product $P=W X_{C}^{T}$ (or $P=X_{B} W$ ).

A trivial extension of Higham \& Mary (2020, Lem. 3.2) to incorporate $D$ shows that if $P$ is computed in uniform precision $u$, the computed $\widehat{P}$ satisfies

$$
\begin{equation*}
\widehat{P}=B D C+\Delta P, \quad\|\Delta P\| \lesssim c u\|B\|\|D\|\|C\| \tag{4.10}
\end{equation*}
$$

where $c=b+2 r^{3 / 2}$.
We now consider the case where $B$ and $C$ are partitioned into $p$ groups $B_{\ell}=X_{B \ell} Y_{B \ell}^{T}$ and $C_{m}=$ $Y_{C m} X_{C m}^{T}$, stored in precision $u_{\ell}$ and $u_{m}$, respectively. We assume that matrices $B$ and $C$ satisfy $\left\|B_{\ell} D\right\| \leqslant$ $\varepsilon \beta_{B} / u_{\ell}$ and $\left\|D C_{m}\right\| \leqslant \varepsilon \beta_{C} / u_{m}$ for $\ell, m>1$. We analyze each of the three steps separately.
4.2.1 Inner product $M=Y_{B}^{T} D Y_{C}$. Let us first analyze the computation of the inner product $M$. Assume $M_{\ell m}=Y_{B \ell}^{T} D Y_{C m}$ is computed in a given precision denoted as $u_{\ell m}^{M}$. The computed $\widehat{M}_{\ell m}$ satisfies $\widehat{M}_{\ell m}=M_{\ell m}+\Delta M_{\ell m}$, with

$$
\begin{equation*}
\left|\Delta M_{\ell m}\right| \lesssim b u_{\ell m}^{M}\left|Y_{B \ell}\right|^{T}|D|\left|Y_{C m}\right| \tag{4.11}
\end{equation*}
$$

By taking norms, we obtain

$$
\begin{equation*}
\left\|\Delta M_{\ell m}\right\| \lesssim b u_{\ell m}^{M} \min \left(\alpha_{1}, \alpha_{2}, \alpha_{3}\right) \tag{4.12}
\end{equation*}
$$

where

$$
\begin{array}{ll}
\alpha_{1}=\left\|B_{\ell} D\right\|\left\|C_{m}\right\|, & \alpha_{1} \leqslant \varepsilon \beta_{B}\left\|C_{m}\right\| / u_{\ell} \text { if } \ell>1 \\
\alpha_{2}=\left\|B_{\ell}\right\|\left\|D C_{m}\right\|, & \alpha_{2} \leqslant \varepsilon\left\|B_{\ell}\right\| \beta_{C} / u_{m} \text { if } m>1 \\
\alpha_{3}=\left\|B_{\ell} D\right\|\left\|D^{-1}\right\|\left\|D C_{m}\right\|, & \alpha_{3} \leqslant \varepsilon^{2} \beta_{B} \beta_{C}\left\|D^{-1}\right\| /\left(u_{\ell} u_{m}\right) \text { if } \ell, m>1 . \tag{4.15}
\end{array}
$$

From this we can deduce the optimal choices of precisions $u_{\ell m}^{M}$ that still guarantee an error of order $\varepsilon$.

- If $\ell=m=1$, in general we must take $u_{11}^{M}=u_{1}$ since $\left\|B_{1}\right\|$ and $\left\|C_{1}\right\|$ are not bounded in terms of $\varepsilon$. We obtain

$$
\begin{equation*}
\left\|\Delta M_{11}\right\| \lesssim b u_{1}\left\|B_{1}\right\|\|D\|\left\|C_{1}\right\| . \tag{4.16}
\end{equation*}
$$

- If $\ell=1$ and $m>1, \alpha_{2} \leqslant \varepsilon / u_{m}\|B\| \beta_{C}$, and so taking $u_{1 m}^{M}=u_{m}$ yields an error of order $\varepsilon$ :

$$
\begin{equation*}
\left\|\Delta M_{1 m}\right\| \lesssim b \varepsilon\left\|B_{1}\right\| \beta_{C} \tag{4.17}
\end{equation*}
$$

Similarly, we can take $u_{\ell 1}^{M}=u_{\ell}$ and obtain

$$
\begin{equation*}
\left\|\Delta M_{\ell 1}\right\| \lesssim b \varepsilon \beta_{B}\left\|C_{1}\right\| . \tag{4.18}
\end{equation*}
$$

- If $\ell, m>1$, we can safely take $u_{\ell m}^{M}=\max \left(u_{\ell}, u_{m}\right)=u_{\max (\ell, m)}$. Indeed, if $\ell \geqslant m$ we can use (4.13) and if $\ell<m$ we can use (4.14), and so, in any case, we have

$$
\begin{equation*}
\left\|\Delta M_{\ell m}\right\| \lesssim b \varepsilon \max \left(\beta_{B}\left\|C_{1}\right\|,\left\|B_{1}\right\| \beta_{C}\right) \tag{4.19}
\end{equation*}
$$

Combining (4.16), (4.17), (4.18), and (4.19), we obtain for $\ell, m \geqslant 1$

$$
\begin{equation*}
\left\|\Delta M_{\ell m}\right\| \lesssim b \max \left(\varepsilon \beta_{B}\left\|C_{1}\right\|, \varepsilon\left\|B_{1}\right\| \beta_{C}, u_{1}\left\|B_{1}\right\|\|D\|\left\|C_{1}\right\|\right) \tag{4.20}
\end{equation*}
$$

In summary, for any value of $\ell$ and $m$, we can compute the product between the part of $B$ stored in precision $u_{\ell}$ and the part of $C$ stored in precision $u_{m}$ in the lower of the two precisions. This is a crucial observation that allows us to maximize the use of lower precision.

Moreover, in some cases we may actually take $u_{\ell m}^{M}>\max \left(u_{\ell}, u_{m}\right)$ because of (4.15). To see why, let us take an example where $\left\|D^{-1}\right\|, \beta_{B}, \beta_{C}$, and $\|A\|$ are all approximately equal to 1 . In this case, for $\ell, m>1$, (4.12) reduces to

$$
\begin{equation*}
\left\|\Delta M_{\ell m}\right\| \lesssim b u_{\ell m}^{M} \varepsilon^{2} /\left(u_{\ell} u_{m}\right) \tag{4.21}
\end{equation*}
$$

and so the requirement to obtain an error of order $\varepsilon$ is

$$
\begin{equation*}
b u_{\ell m}^{M} \varepsilon \leqslant u_{\ell} u_{m} \tag{4.22}
\end{equation*}
$$

which thus depends not only on $u_{\ell}$ and $u_{m}$, but also on $\varepsilon$. If $\varepsilon$ is small enough, (4.22) may be satisfied even for $u_{\ell m}^{M}>\max \left(u_{\ell}, u_{m}\right)$. For example, assume we have three precisions $u_{1}=u_{d}=2^{-53}, u_{2}=u_{s}=$ $2^{-24}$, and $u_{3}=u_{h}=2^{-8}$. Then, ignoring the constant $b$ in (4.22):

- The condition $u_{22}^{M} \varepsilon \leqslant u_{2}^{2}$ is satisfied for $u_{22}^{M}=u_{3}$ if $\varepsilon \leqslant u_{s}^{2} / u_{h} \approx 9 \times 10^{-13}$. Thus, if $\varepsilon$ is small enough, $M_{22}$ need only be computed in half precision.
- The condition $u_{23}^{M} \varepsilon \leqslant u_{2} u_{3}$ is satisfied for $u_{23}^{M}=1$ if $\varepsilon \leqslant u_{s} u_{h} \approx 2 \times 10^{-10}$. The same holds for $u_{32}^{M}$. Thus, if $\varepsilon$ is small enough, the computation of $M_{23}$ and $M_{32}$ may be skipped altogether.
- Finally, the condition $u_{33}^{M} \varepsilon \leqslant u_{3}^{2}$ is satisfied for $u_{33}^{M}=1$ if $\varepsilon \leqslant u_{h}^{2} \approx 2 \times 10^{-5}$. Again, the computation of $M_{33}$ may be skipped in this case.
Going back to the general case, the precise requirement on $u_{\ell m}^{M}$ depends on $u_{\ell}, u_{m}, \varepsilon, \beta_{B}, \beta_{C}$, and $\left\|D^{-1}\right\|$. For global compression ( $\beta_{B}=\beta_{C}=\|A\|$ ), we obtain

$$
\begin{equation*}
\left\|\Delta M_{\ell m}\right\| \lesssim b u_{\ell m}^{M} \varepsilon^{2}\|A\|^{2}\left\|D^{-1}\right\| /\left(u_{\ell} u_{m}\right) \tag{4.23}
\end{equation*}
$$

4.2.2 Middle product $W=X_{B} M$ (or $W=M Y_{C}^{T}$ ). We analyze the product $W=X_{B} M$, the case of $W=M Y_{C}^{T}$ being analogous. Let $W_{m}=\sum_{\ell=1}^{p} X_{B \ell} M_{\ell m}$, for $m=1: p$. Assume the product $W_{m}^{(\ell)}=X_{B \ell} M_{\ell m}$ is computed in precision $u_{\ell m}^{W}$, then the computed $\widehat{W}_{m}^{(\ell)}$ satisfies

$$
\begin{align*}
\widehat{W}_{m}^{(\ell)} & =X_{B \ell} \widehat{M}_{\ell m}+\Delta W_{m}^{(\ell)}  \tag{4.24}\\
\left\|\Delta W_{m}^{(\ell)}\right\| & \lesssim r_{\ell} u_{\ell m}^{W}\left\|X_{B \ell}\right\|\left\|\widehat{M}_{\ell m}\right\| \lesssim r_{\ell}^{3 / 2} u_{\ell m}^{W}\left\|B_{\ell} D C_{m}\right\| . \tag{4.25}
\end{align*}
$$

This bound on $\left\|\Delta W_{m}^{(\ell)}\right\|$ is similar to the bound (4.12) on $\left\|\Delta M_{\ell m}\right\|$, and we should therefore set $u_{\ell m}^{W}=$ $u_{\ell m}^{M}$. Then, similarly to Algorithm 2, the partial results $W_{m}^{(\ell)}$ should be summed in reverse order and in
increasing precision, since $W_{m}^{(\ell)}+W_{m}^{(\ell+1)}$ must be computed in precision $u_{\ell m}^{W}$. Overall, with $u_{\ell m}^{W}=u_{\ell m}^{M}=$ $\max \left(u_{\ell}, u_{m}\right)$, the computed $\widehat{W}_{m}$ satisfies

$$
\begin{align*}
\widehat{W}_{m} & =\sum_{\ell=1}^{p} \widehat{W}_{m}^{(\ell)} \circ\left(J+\Theta_{\ell}\right), \quad\left|\Theta_{\ell}\right| \lesssim u_{\ell},  \tag{4.26}\\
& =\sum_{\ell=1}^{p}\left(X_{B \ell} M_{\ell m}+X_{B \ell} \Delta M_{\ell m}+\Delta W_{m}^{(\ell)}\right) \circ\left(J+\Theta_{\ell}\right),  \tag{4.27}\\
& =\sum_{\ell=1}^{p} W_{m}^{(\ell)}+\Delta \widehat{W}_{m}^{(\ell)}=W_{m}+\Delta W_{m}, \tag{4.28}
\end{align*}
$$

with

$$
\begin{equation*}
\left\|\Delta \widehat{W}_{m}^{(\ell)}\right\| \lesssim\left(b+r_{\ell}^{3 / 2}+1\right) \max \left(\varepsilon \beta_{B}\|C\|, \varepsilon\|B\| \beta_{C}, u_{1}\|B\|\|D\|\|C\|\right) \tag{4.29}
\end{equation*}
$$

and so

$$
\begin{equation*}
\left\|\Delta W_{m}\right\| \lesssim\left(p b+r^{3 / 2}+p\right) \max \left(\varepsilon \beta_{B}\|C\|, \varepsilon\|B\| \beta_{C}, u_{1}\|B\|\|D\|\|C\|\right) . \tag{4.30}
\end{equation*}
$$

4.2.3 Outer product $P=W X_{C}^{T}$ (or $P=X_{B} W$ ). It remains to analyze the final product $P=W X_{C}^{T}$ (or $P=X_{B} W$, which is analogous). Let $P_{m}=W_{m} X_{C m}^{T}$ be computed in precision $u_{m}^{P}$. Then the computed $\widehat{P}_{m}$ satisfies

$$
\begin{align*}
\widehat{P}_{m} & =\widehat{W}_{m} X_{C m}^{T}+\Delta P_{m},  \tag{4.31}\\
\left\|\Delta P_{m}\right\| & \lesssim r_{m} u_{m}^{P}\left\|\widehat{W}_{m}\right\|\left\|X_{C m}\right\| \leqslant r_{m}^{3 / 2} u_{m}^{P}\left\|\widehat{W}_{m}\right\| \lesssim r_{m}^{3 / 2} u_{m}^{P} \sum_{\ell=1}^{p}\left\|B_{\ell} D C_{m}\right\| . \tag{4.32}
\end{align*}
$$

Since $\sum_{\ell=1}^{p}\left\|B_{\ell} D C_{m}\right\|$ is at least as large as $\left\|B_{1} D C_{m}\right\|$, by (4.14) we must take $u_{m}^{P}=u_{m}$. Then, (4.32) becomes

$$
\begin{equation*}
\left\|\Delta P_{m}\right\| \lesssim r_{m}^{3 / 2} \max \left(\varepsilon\|B\| \beta_{C}, u_{1}\|B\|\|D\|\|C\|\right) \tag{4.33}
\end{equation*}
$$

Finally, as previously for $W_{m}$, we sum $P_{m}$ over $m$ in reverse order and in increasing precision, to obtain a computed $\widehat{P}$ satisfying

$$
\begin{align*}
\widehat{P} & =\sum_{m=1}^{p} \widehat{P}_{m} \circ\left(J+\Theta_{m}\right), \quad\left|\Theta_{m}\right| \lesssim u_{m},  \tag{4.34}\\
& =\sum_{m=1}^{p}\left(\widehat{W}_{m}\left(X_{C m}\right)^{T}+\Delta P_{m}\right) \circ\left(J+\Theta_{m}\right),  \tag{4.35}\\
& =\sum_{m=1}^{p} P_{m}+\left(\Delta W_{m} X_{C m}^{T}+\Delta P_{m}\right) \circ\left(J+\Theta_{m}\right),  \tag{4.36}\\
& =P+\Delta P, \tag{4.37}
\end{align*}
$$

with

$$
\begin{equation*}
\|\Delta P\| \lesssim\left(p^{2} b+(p+1) r^{3 / 2}+p^{2}+p\right) \max \left(\varepsilon \beta_{B}\|C\|, \varepsilon\|B\| \beta_{C}, u_{1}\|B\|\|D\|\|C\|\right) \tag{4.38}
\end{equation*}
$$

This concludes the analysis of the product $P$. We summarize the approach suggested by this analysis in Algorithm 3, for which the following theorem holds.

THEOREM 4.2 (Low-rank times low-rank) Let $B=\sum_{\ell=1}^{p} B_{\ell}$ and $C=\sum_{m=1}^{p} C_{m}$ be two mixed precision low-rank matrices satisfying

$$
\begin{align*}
\left\|B_{\ell} D\right\| & \leqslant \varepsilon \beta_{B} / u_{\ell} \text { for } \ell>1  \tag{4.39}\\
\left\|D C_{m}\right\| & \leqslant \varepsilon \beta_{C} / u_{m} \text { for } m>1 \tag{4.40}
\end{align*}
$$

and $D$ a diagonal matrix, and let $P=B D C$ be computed as described in Algorithm 3. Then, the computed $\widehat{P}$ satisfies

$$
\begin{equation*}
\widehat{P}=B D C+\Delta P, \quad\|\Delta P\| \lesssim c \max \left(\varepsilon \beta_{B}\|C\|, \varepsilon\|B\| \beta_{C}, u_{1}\|B\|\|D\|\|C\|\right) \tag{4.41}
\end{equation*}
$$

with $c=p^{2} b+(p+1) r^{3 / 2}+p^{2}+p$.

### 4.3 Triangular system with low-rank right-hand side

The last kernel that we need to analyze is the solution of a triangular system $L D Z=B$, where $L \in \mathbb{R}^{b \times b}$ is lower triangular, $D$ is diagonal, and the right-hand side $B=Y X^{T}$ is a mixed precision low-rank matrix. We analyze the kernel for a lower triangular matrix $L$, the upper triangular case ( $Z D U=B$ ) being analogous. For this kernel, the output (the solution $Z$ ) is needed under low-rank form.

In the uniform precision case, if the system $L D Z=B$ is solved in uniform precision $u$, the computed solution $\widehat{Z}$ satisfies (Higham \& Mary, 2020, Lemma 3.5)

$$
\begin{equation*}
L D \widehat{Z}=B+\Delta B, \quad\|\Delta B\| \lesssim b u\|L\|\|D\|\|\widehat{Z}\| \tag{4.42}
\end{equation*}
$$

Let $B_{\ell}=Y_{\ell} X_{\ell}^{T}$ be the part of $B$ that is stored in precision $u_{\ell}$, satisfying $\left\|B_{\ell}\right\|=\left\|Y_{\ell}\right\| \leqslant \varepsilon \beta / u_{\ell}$ for $\ell>1$. Then, the natural approach to solve $L D Z=B$ in mixed precision is to solve each system $L D V_{\ell}=Y_{\ell}$ in precision $u_{\ell}$ and to define $Z_{\ell}=V_{\ell} X_{\ell}^{T}$, which yields the mixed precision low-rank solution $Z=\sum_{\ell=1}^{p} Z_{\ell}$. However, a traditional normwise analysis based on (4.42) does not provide a satisfactory bound here: if we apply (4.42) to $L D V_{\ell}=Y_{\ell}$ and use $\widehat{V}_{\ell} \approx D^{-1} L^{-1} Y_{\ell}$, we obtain the bound

$$
\begin{equation*}
L D \widehat{V}_{\ell}=Y_{\ell}+\Delta Y_{\ell}, \quad\left\|\Delta Y_{\ell}\right\| \lesssim b \varepsilon \beta \kappa(L) \kappa(D) \tag{4.43}
\end{equation*}
$$

This bound is very weak due to the presence of the normwise condition numbers $\kappa(L) \kappa(D)=\|L\|\left\|L^{-1}\right\|\|D\|\left\|D^{-1}\right\|$.

A stronger bound can be obtained by using a componentwise analysis:

$$
\begin{equation*}
L D \widehat{V}_{\ell}=Y_{\ell}+\Delta Y_{\ell}, \quad\left|\Delta Y_{\ell}\right| \lesssim b u_{\ell}|L||D|\left|\widehat{V}_{\ell}\right| . \tag{4.44}
\end{equation*}
$$

Replacing $\widehat{V}_{\ell}$ by $D^{-1} L^{-1}\left(Y_{\ell}+\Delta Y_{\ell}\right)$ in the bound on $\Delta Y_{\ell}$ yields

$$
\begin{equation*}
\left|\Delta Y_{\ell}\right| \lesssim b u_{\ell}|L|\left|D \| D^{-1} L^{-1} Y_{\ell}\right| \leqslant b u_{\ell}|L|\left|L^{-1}\right|\left|Y_{\ell}\right| \tag{4.45}
\end{equation*}
$$

We can now take norms, obtaining for $\ell>1$

$$
\begin{equation*}
\left\|\Delta Y_{\ell}\right\| \lesssim b u_{\ell} \operatorname{cond}\left(L, Y_{\ell}\right)\left\|Y_{\ell}\right\| \leqslant b \varepsilon \beta \operatorname{cond}\left(L, Y_{\ell}\right) \tag{4.46}
\end{equation*}
$$

where $\operatorname{cond}\left(L, Y_{\ell}\right)$ is the condition number introduced by Skeel (1979) (Higham, 2002, Eq. (7.13)):

$$
\begin{equation*}
\operatorname{cond}\left(L, Y_{\ell}\right)=\frac{\left\|| L | \left|L^{-1}\left\|Y_{\ell} \mid\right\|\right.\right.}{\left\|Y_{\ell}\right\|} \tag{4.47}
\end{equation*}
$$

Multiplying both sides of (4.44) by $X_{\ell}^{T}$ on the right yields

$$
\begin{equation*}
L D \widehat{Z}_{\ell}=B_{\ell}+\Delta Y_{\ell} X_{\ell}^{T} \tag{4.48}
\end{equation*}
$$

Summing (4.48) over $\ell$, we obtain

$$
\begin{align*}
& L D \widehat{Z}=B+\sum_{\ell=1}^{p} \Delta Y_{\ell} X_{\ell}^{T}=B+\Delta B  \tag{4.49}\\
& \|\Delta B\| \lesssim b u_{1}\|L\|\|D\|\left\|\widehat{Z}_{1}\right\|+p b \varepsilon \beta \operatorname{cond}(L) \tag{4.50}
\end{align*}
$$

where cond $(L)=\left\|\left|L^{-1}\right||L|\right\|$.
The use of intermediate componentwise bounds presents two advantages. First, we obtain a bound with cond $(L)$, which is in general smaller than $\kappa(L)$ (see Higham (2002, p. 123) for a discussion on the difference between these two quantities). Second and more importantly, we have dropped the matrix $D$ from the term proportional to $\varepsilon \beta$, which shows that this term is invariant under scaling and which represents a significant improvement since $\kappa(D) \approx \kappa(A)$ can be arbitrarily large. Importantly, in the case of an LDU factorization with partial pivoting, both $L$ and $U$ are well conditioned, and cond $(L)$ is in practice a small constant. Therefore, in the context of Algorithm 1, the mixed precision triangular solution analyzed here is backward stable. However, for a general system $L D Z=B$, bound (4.50) does not guarantee backward stability, and indeed some examples can be built where the use of mixed precision arithmetic in the solution of the system leads to a large increase of the backward error (we note however that such examples are very hard to find and we were only able to construct one using direct search optimization (Higham, 1993)).

We summarize the proposed approach to solve $L D Z=B$ in Algorithm 4 and its error analysis in the following theorem.

THEOREM 4.3 Let $L \in \mathbb{R}^{b \times b}$ be a lower triangular full-rank matrix and let $B=\sum_{\ell=1}^{p} B_{\ell}$ be a mixed precision low-rank matrix satisfying $\left\|B_{\ell}\right\| \leqslant \beta \varepsilon / u_{\ell}$. If the system $L D Z=B$ is solved by Algorithm 4, the computed solution $\widehat{Z}$ satisfies

$$
\begin{equation*}
L D \widehat{Z}=B+\Delta B, \quad\|\Delta B\| \lesssim p b \varepsilon \beta \operatorname{cond}(L)+b u_{1}\|L\|\|D\|\|\widehat{Z}\| . \tag{4.51}
\end{equation*}
$$

### 4.4 Putting everything together: error analysis of mixed precision BLR LU factorization

Now that we have analyzed all the kernels of Algorithm 1, we are ready to prove the backward stability of the BLR LU factorization in mixed precision arithmetic. We define

$$
\begin{equation*}
\lambda_{1}=\max _{k=1: q} \max \left(\left\|L_{k k}^{-1}\right\|,\left\|U_{k k}^{-1}\right\|, \operatorname{cond}\left(L_{k k}\right), \operatorname{cond}\left(U_{k k}\right)\right) \tag{4.52}
\end{equation*}
$$

If partial pivoting is performed, $\lambda_{1}$ is almost always small in practice and of order a constant (Higham, 2002, Chapter 8), even though in theory it can only be bounded by $2^{b}-1$ (Higham, 2002, Lemma 8.6). We also define

$$
\begin{equation*}
\lambda_{2}=\max _{i \geqslant j} \max \left(\left\|L_{i j}\right\|,\left\|U_{j i}\right\|\right) \tag{4.53}
\end{equation*}
$$

If partial pivoting is performed, $\lambda_{2} \leqslant b$.
Let us bound the error incurred in the computation of some $(i, k)$ block of the $L$ factor, the $U$ factor analysis being similar. For $i<k, L_{i k}$ is obtained by solving

$$
\begin{equation*}
L_{i k} D_{k k} U_{k k}=T_{i k}, \tag{4.54}
\end{equation*}
$$

where $T_{i k}$ is the compressed form of

$$
\begin{equation*}
R_{i k}=A_{i k}-\sum_{j=1}^{k-1} \widehat{L}_{i j} D_{j j} \widehat{U}_{j k} \tag{4.55}
\end{equation*}
$$

where $\widehat{L}_{i j}$ and $\widehat{U}_{j k}$ are the LU factors computed at the previous steps, and are represented as mixed precision low-rank matrices, and the product $\widehat{L}_{i j} D_{j j} \widehat{U}_{j k}$ is computed with Algorithm 3. Note that if one of $\widehat{L}_{i j}$ or $\widehat{U}_{j k}$ is a full-rank matrix, the analysis is similar and relies on Theorem 4.1; if both are full-rank, the computation is done in uniform precision $u_{1} \ll \varepsilon$ and introduces an error term $b u_{1}\left\|\widehat{L}_{i j}\right\|\left\|D_{j j}\right\|\left\|\widehat{U}_{j k}\right\|$. The difficulty is that $\widehat{L}_{i j}$ and $\widehat{U}_{j k}$ are not directly the result of a compression, and so we cannot directly control the norms of $\widehat{L}_{i j}^{(\ell)}$ and $\widehat{U}_{j k}^{(m)}$, the parts of $\widehat{L}_{i j}$ and $\widehat{U}_{j k}$ stored in precision $u_{\ell}$ and $u_{m}$, respectively. Instead, they are given by

$$
\begin{align*}
\widehat{L}_{i j}^{(\ell)} & \approx T_{i j}^{(\ell)} \widehat{U}_{j j}^{-1} D_{j j}^{-1}  \tag{4.56}\\
\widehat{U}_{j k}^{(m)} & \approx D_{j j}^{-1} \widehat{L}_{j j}^{-1} T_{j k}^{(m)} \tag{4.57}
\end{align*}
$$

where $T_{i j}$ and $T_{j k}$ have been compressed such that

$$
\begin{align*}
& \left\|T_{i j}^{(\ell)}\right\| \leqslant \varepsilon \beta_{i j} / u_{\ell} \text { for } \ell>1  \tag{4.58}\\
& \left\|T_{j k}^{(m)}\right\| \leqslant \varepsilon \beta_{j k} / u_{m} \text { for } m>1 \tag{4.59}
\end{align*}
$$

Therefore, the norms of $\widehat{L}_{i j}^{(\ell)}$ and $\widehat{U}_{j k}^{(m)}$ depend on $\beta_{i j}$ and $\beta_{j k}$, respectively, but also on the scaling factors in $D_{j j}$. However, one of the two $D_{j j}^{-1}$ in (4.56)-(4.57) is cancelled by the $D_{j j}$ in (4.55) and $\left\|\widehat{L}_{j j}^{-1}\right\|$ and $\left\|\widehat{U}_{j j}^{-1}\right\|$ are both bounded by $\lambda_{1}$. As a result, we can rewrite the product $R_{i k, j}=\widehat{L}_{i j} D_{j j} \widehat{U}_{j k}$ as $B D C$, where

$$
\begin{align*}
\left\|B_{\ell} D\right\| & \lesssim \lambda_{1} \varepsilon \beta_{i j} / u_{\ell} \text { for } \ell>1  \tag{4.60}\\
\left\|D C_{m}\right\| & \lesssim \lambda_{1} \varepsilon \beta_{j k} / u_{m} \text { for } m>1 \tag{4.61}
\end{align*}
$$

By Theorem 4.2, the computed $\widehat{R}_{i k, j}$ satisfies

$$
\begin{align*}
& \widehat{R}_{i k, j}=\widehat{L}_{i j} D_{j j} \widehat{U}_{j k}+\Delta R_{i k, j}  \tag{4.62}\\
& \left\|\Delta R_{i k, j}\right\| \lesssim c \max \left(\lambda_{1} \varepsilon \beta_{i j}\left\|\widehat{U}_{j k}\right\|, \lambda_{1} \varepsilon \beta_{j k}\left\|\widehat{L}_{i j}\right\|, u_{1}\left\|\widehat{L}_{i j}\right\|\left\|D_{j j}\right\|\left\|\widehat{U}_{j k}\right\|\right) \tag{4.63}
\end{align*}
$$

By (4.55), we obtain a computed $\widehat{R}_{i k}$

$$
\begin{equation*}
\widehat{R}_{i k}=A_{i k} \circ\left(J+\Theta_{k}\right)-\sum_{j=1}^{k-1}\left(\widehat{L}_{i j} D_{j j} \widehat{U}_{j k}+\Delta R_{i k, j}\right) \circ\left(J+\Theta_{j}\right), \tag{4.64}
\end{equation*}
$$

where $\left|\Theta_{j}\right| \leqslant \gamma_{j}^{(1)} J$ accounts for the errors in the additions of the products $\widehat{R}_{i k, j}$ to $A_{i k}$. We thus obtain

$$
\begin{align*}
& \widehat{R}_{i k}=A_{i k}-\sum_{j=1}^{k-1} \widehat{L}_{i j} D_{j j} \widehat{U}_{j k}+\Delta R_{i k}  \tag{4.65}\\
& \left\|\Delta R_{i k}\right\| \lesssim k u_{1}\left\|A_{i k}\right\|+\sum_{j=1}^{k-1} \max \left(\lambda_{1} \lambda_{2} c \varepsilon \max \left(\beta_{i j}, \beta_{j k}\right),\left(\lambda_{2}^{2} c+j\right) u_{1}\left\|D_{j j}\right\|\right) \tag{4.66}
\end{align*}
$$

$\widehat{R}_{i k}$ is then compressed into $T_{i k}$ such that the part of $T_{i k}$ stored in precision $u_{\ell}$ satisfies

$$
\begin{equation*}
T_{i k}^{(\ell)}=\widehat{R}_{i k}^{(\ell)}+E_{i k}^{(\ell)}, \quad\left\|E_{i k}^{(\ell)}\right\| \leqslant \varepsilon \beta_{i k} / u_{\ell} \tag{4.67}
\end{equation*}
$$

and so overall, by Theorem 2.1,

$$
\begin{equation*}
T_{i k}=\widehat{R}_{i k}+E_{i k}, \quad\left\|E_{i k}\right\| \lesssim(2 p-1) \varepsilon \beta_{i k} \tag{4.68}
\end{equation*}
$$

Finally, we solve (4.54) for $L_{i k}$, and by Theorem 4.3, the computed $\widehat{L}_{i k}$ satisfies

$$
\begin{equation*}
\widehat{L}_{i k} D_{k k} \widehat{U}_{k k}=T_{i k}+F_{i k}, \quad\left\|F_{i k}\right\| \lesssim p b \lambda_{1} \varepsilon \beta_{i k}+b u_{1} \lambda_{2}^{2}\left\|D_{k k}\right\| \tag{4.69}
\end{equation*}
$$

Putting together (4.69), (4.68), (4.66), we obtain

$$
\begin{equation*}
\widehat{L}_{i k} D_{k k} \widehat{U}_{k k}=A_{i k}-\sum_{j=1}^{k-1} \widehat{L}_{i j} D_{j j} \widehat{U}_{j k}+\Delta R_{i k}+E_{i k}+F_{i k} \tag{4.70}
\end{equation*}
$$

and so

$$
\begin{align*}
& A_{i k}=\sum_{j=1}^{k} \widehat{L}_{i j} D_{j j} \widehat{U}_{j k}+\Delta A_{i k},  \tag{4.71}\\
& \left\|\Delta A_{i k}\right\| \lesssim k u_{1}\left\|A_{i k}\right\|+\sum_{j=1}^{k} \max \left(\lambda_{1} \lambda_{2} c \varepsilon \max \left(\beta_{i j}, \beta_{j k}\right),\left(\lambda_{2}^{2} c+j\right) u_{1}\left\|D_{j j}\right\|\right) . \tag{4.72}
\end{align*}
$$

With the choice $\beta_{i j}=\beta_{j k}=\|A\|$ for $j=1: k$, and since $k \leqslant q$, we obtain

$$
\begin{equation*}
\left\|\Delta A_{i k}\right\| \lesssim \lambda_{1} \lambda_{2} c q \varepsilon\|A\|+q u_{1}\left\|A_{i k}\right\|+q\left(\lambda_{2}^{2} c+q\right) \rho u_{1}\|A\| \tag{4.73}
\end{equation*}
$$

where we have used $\left\|D_{j j}\right\| \leqslant \rho\|A\|$, where $\rho$ denotes the growth factor. This concludes the case $i<k$. Bounds analogous to (4.73) hold for $i=k$ and $i>k$, and so overall we have

$$
\begin{equation*}
A=\widehat{L} D \widehat{U}+\Delta A, \quad\|\Delta A\| \lesssim q^{2}\left(\lambda_{1} \lambda_{2} c \varepsilon+\left(\lambda_{2}^{2} c+q\right) \rho u_{1}\right)\|A\| \tag{4.74}
\end{equation*}
$$

We summarize this analysis in the next theorem.
THEOREM 4.4 (Mixed precision BLR LU factorization) Let $A \in \mathbb{R}^{n \times n}$ be a BLR matrix partitioned into $q^{2}$ blocks of order $b$. If the BLR LU factorization of $A$ in $p$ precisions described by Algorithms 1-4 runs to completion, the computed LU factors satisfy

$$
\begin{equation*}
A=\widehat{L} D \widehat{U}+\Delta A, \quad\|\Delta A\| \lesssim q^{2}\left(\lambda_{1} \lambda_{2} c \varepsilon+\left(\lambda_{2}^{2} c+q\right) \rho u_{1}\right)\|A\| \tag{4.75}
\end{equation*}
$$

where $\lambda_{1}$ and $\lambda_{2}$ are defined by (4.52)-(4.53), $\rho$ is the growth factor, and $c=p^{2} b+(p+1) r^{3 / 2}+p$.
Theorem 4.4 therefore proves the backward stability of the mixed precision BLR LU factorization: the computed LU factors give an exact LU decomposition of a perturbed matrix, where the norm of the perturbation $\|\Delta A\|$ is of order $\varepsilon$. The precise value of the constants $q^{2} \lambda_{1} \lambda_{2} c$ and $q^{2}\left(\lambda_{2}^{2} c+q\right) \rho$ in (4.75) is not of great importance but, as a check, we compare it against the uniform precision bound of Higham \& Mary (2020, Thm. 4.3)

$$
\begin{equation*}
A=\widehat{L} \widehat{U}+\Delta A, \quad\|\Delta A\| \lesssim q \varepsilon\|A\|+\left(b+2 r^{3 / 2}+q\right) u_{1}\|\widehat{L}\|\|\widehat{U}\| . \tag{4.76}
\end{equation*}
$$

Since $\|\widehat{L}\|\|\widehat{U}\| \lesssim n^{2} \rho\|A\|$ and, with partial pivoting, $\lambda_{2} \leqslant b$, we see that both (4.75) and (4.76) grow as $O\left(n^{2}(b+q) \rho\right)$.

After Theorem 4.4, not much additional effort is needed to prove the backward stability of the solution of linear systems $A x=v$ by mixed precision BLR LU factorization. We note that mixed precision arithmetic can also be used in the solution of the triangular systems with the LU factors, but in the interest of space, we omit these details.

## 5. Experimental results

### 5.1 Experimental setting

We have written a MATLAB code that implements a mixed precision variant of Algorithm 1 that uses Algorithms 2-4. Our implementation can use any number of arbitrary precisions, where the lower precisions are simulated using the chop function of Higham \& Pranesh (2019). To compress the blocks,

we use a mixed precision truncated QR decomposition with column pivoting-we omit a detailed description of this algorithm, which we plan to investigate more in depth in future work. We have made our code publicly available online ${ }^{2}$.

For our experiments, we use the matrices listed in Table 1. These matrices are all obtained as the Schur complement of larger sparse matrices (specifically, the root separators of their multifrontal factorization) arising in various applications: P64 comes from the discretization of a Poisson equation, perf009d comes from a structural mechanics problem from EDF (French electricity supplier), the others come from the SuiteSparse collection (Davis \& Hu, 2011).

To confirm experimentally the numerical stability of the algorithms, and to assess the impact of mixed precision arithmetic on their accuracy, we measure backward errors. Rather than measuring the backward error for the LU factorization, which is expensive to compute, we use the computed LU factors to solve a linear system $A x=v$, where $x$ is the vector of ones (and $v$ is computed as $A x$ ), and we use the computed solution $\hat{x}$ to measure the backward error

$$
\begin{equation*}
\frac{\|A \widehat{x}-v\|}{\|A\|\|\widehat{x}\|} \tag{5.1}
\end{equation*}
$$

given by the Rigal-Gaches theorem (Higham (2002, Thm 7.1), Rigal \& Gaches (1967)).
To evaluate the potential of using mixed precision for the BLR LU factorization, we will focus on two performance metrics: the storage cost for the factorized matrix and the expected time cost of the factorization. Both these costs depend on the relative performance of each arithmetic. It is easy to measure the storage cost since, for each arithmetic, it is proportional to the number of bits used: an fp32 number requires half the storage of an fp64 one, and a bfloat16 number requires a quarter of the storage. Hence, we have

$$
\begin{equation*}
\text { storage cost }=(\# \text { entries in fp64 })+0.5 \times(\# \text { entries in fp32 })+0.25 \times(\# \text { entries in bf16 }) \tag{5.2}
\end{equation*}
$$

The time cost will be estimated based on the number of flops performed in each arithmetic. This is a more complex issue because the relative speed of each arithmetic strongly depends on the hardware, the

matrix, and several other factors. A practical high performance implementation of the mixed precision BLR factorization is outside our scope but, as a rough indicator, we make the assumption that the speed of each arithmetic is also proportional to the number of bits. Hence, we use the cost model

$$
\begin{equation*}
\text { expected time cost }=(\# \text { flops in fp64 })+0.5 \times(\# \text { flops in fp32 })+0.25 \times(\# \text { flops in bf } 16) \tag{5.3}
\end{equation*}
$$

### 5.2 Performance-accuracy tradeoff

The analytical error bounds obtained in section 4 show that the use of mixed precision arithmetic should only increase the backward error by a small constant. In this first experiment, we check experimentally (i) that the error increase is indeed small, and (ii) whether the expected time and storage gains obtained by the use of mixed precision justify this error increase, that is, whether the mixed precision variant achieves a better performance-accuracy tradeoff than the uniform precision variant. Indeed, since the mixed precision variant achieves a slightly larger error, to be completely fair, we should compare it against the uniform precision variant with a correspondingly larger $\varepsilon$.

To answer this question, we perform the following experiment in Figure 4: taking several values of $\varepsilon$ ranging from $10^{-16}$ to $10^{-6}$, we plot the gains in storage and expected time (5.2) and (5.3) as a function of the error (5.1). We compare three variants of the BLR factorization: the standard uniform precision variant run entirely with fp64 arithmetic, a two-precision variant using both fp64 and fp32, and a threeprecision variant using bfloat 16 as well. The figure shows that the two-precision variant achieves a much better performance-accuracy tradeoff than the uniform precision one, and that the three-precision variant further improves this tradeoff. Indeed, using lower precisions slightly increases the error, but the experiment shows that this increase is largely compensated by the costs reductions. Indeed, the closer a variant is to the top left corner of the plots, the better its tradeoff is: for a given accuracy, it is less costly than the other variants, or, equivalently, for a given cost, it achieves an improved accuracy.

In light of this experiment, and to avoid hand-tuning $\varepsilon$ for every variant and every matrix, in the remainder of our experiments we directly compare the variants with the same value of $\varepsilon$.

### 5.3 Results on real-life matrices

In this section we experiment on the real-life matrices listed in Table 1. Figure 5 compares the backward error (5.1) achieved by the BLR factorization for three values of $\varepsilon: 10^{-12}, 10^{-9}$, and $10^{-6}$. For $\varepsilon=10^{-6}$, we compare the uniform fp 32 precision BLR factorization with the two-precision one using fp 32 and bfloat 16 ; for $\varepsilon=10^{-9}$ and $10^{-12}$, we compare the uniform fp64 precision factorization with both a twoprecision variant (using fp64 and fp32) and a three-precision one (also using bfloat16). The figure shows that the use of mixed precision arithmetic does not significantly impact the backward error, leading to an increase of at most an order of magnitude in the worst case (and very often much less than that).

Figure 6 shows the associated storage and time gains expected from the use of mixed precision arithmetic. For each matrix, each bar corresponds to a different value of $\varepsilon$. For $\varepsilon=10^{-12}$ and $10^{-9}$, we focus on the gains achieved by the three-precision variant. The $y$-axis (height of the bars) indicates the number of entries (or number of flops) required by the mixed precision variant as a percentage of the uniform precision one. For storage, this percentage is at least $100 \%$, but can be slightly larger because of the difference between conditions (2.24) and (2.25). Indeed, as explained in section 2, there are some blocks that satisfy (2.25) but do not satisfy (2.24): that is, we allow the mixed precision variant to store more entries, because we expect this increase to pay off thanks to the use of lower precisions. As a result, the percentage for the flops can also differ from $100 \%$, either being larger or smaller.

The colors breakdown in Figure 6 shows the proportion of entries that are stored in each precision, and the proportion of flops that are performed in each precision. For $\varepsilon=10^{-6}$, note that the mixed precision algorithm recovers the fact that we do not need any entries or flops in fp64 arithmetic, since $\varepsilon>u_{s}$. For all matrices there is a significant fraction of the entries and flops that can be switched to

lower precisions, even for $\varepsilon=10^{-12}$. This is a very positive result that confirms that BLR matrices are amenable to the use of mixed precision arithmetic and that the proposed mixed precision BLR representation can achieve very significant gains with respect to the uniform precision one.

The number on top of each bar in Figure 6 indicates the resulting gains in storage and expected time achieved by the mixed precision variant compared with the double precision variant. The figure shows very significant reductions, of up to a factor $2.8 \times$ in storage and $3.5 \times$ in expected time for $\varepsilon=10^{-9}$.

Finally, in Figure 7 we perform a similar experiment as in Figure 6 for matrices of increasing size belonging to the same Poisson problem class. This experiment highlights an important and valuable property of the mixed precision BLR factorization: the storage and expected time gains increase with the problem size, as a larger and larger fraction of the entries and flops can be safely switched to lower precisions.

## 6. Conclusion

We have introduced a novel approach to exploit mixed precision arithmetic for low-rank approximations. Given a prescribed accuracy $\varepsilon$, we have proved in Theorem 2.1 that singular vectors associated with sufficiently small singular values can be stored in precisions with unit roundoff larger than $\varepsilon$ while preserving an overall accuracy of order $\varepsilon$. This approach is not only applicable to low-rank matrices built with a singular value decomposition, but also to many other low-rank decompositions, in particular rank-revealing QR (Lemma 2.2).

We have applied this approach to block low-rank (BLR) matrices, for which this new mixed precision low-rank approximation presents a high potential. We have adapted the existing uniform precision BLR LU factorization algorithm (Algorithm 1) to exploit the mixed precision representation of the blocks. We carried out the rounding error analysis of this new algorithm and obtained two keys results. First, we proved in Theorem 4.4 that the use of mixed precision arithmetic does not compromise the numerical stability of BLR LU factorization recently proven by Higham \& Mary (2020). Second, our analysis determines which level of precision is needed for each floating-point operation, and there-
fore guides us towards a method that is both robust and efficient. The resulting mixed precision BLR algorithms are summarized in Algorithms 2, 3, and 4.

We have evaluated the potential of this mixed precision BLR LU factorization on a range of matrices coming from real-life problems from industrial and academic applications. We have shown that a large fraction of the entries and flops can be safely switched to lower precisions. For $\varepsilon=10^{-9}$, by mixing fp64, fp32, and bfloat16 arithmetics, we obtain reductions in storage of up to $2.8 \times$ with respect to uniform precision BLR. Moreover, assuming fp32 and bfloat16 flops are, respectively, twice and four times faster than fp64 ones, we estimate the expected time gains, predicting reductions of up to $3.5 \times$ with respect to uniform precision BLR. We emphasize that these gains are not achieved at the expense of accuracy: for the same accuracy, the mixed precision variant is less expensive than the uniform precision one, or, equivalently, for a fixed storage or work budget, the mixed precision variant is more accurate (Figure 4).

Given the very promising results obtained with this new mixed precision BLR approach, we plan as future work to develop its high performance implementation and integrate it within the sparse direct solver MUMPS (Amestoy et al., 2019b), which already exploits uniform precision BLR compression.
